Comment: BDR 3-383 relates to changing the violation of a temporary protection order that relates to domestic violence from a misdemeanor offense to a gross misdemeanor, and if there is a violation of an extended protection order related to domestic violence it would change the violation from a misdemeanor to a Class D, felony. This would cause cases of this type to require a preliminary hearing at the Justice Court level within 15 days of their arraignment on the charge and then they would be sent to the District Court for entry of a plea since only the District Court can accept a plea on a gross misdemeanor or felony case. Depending on how many of these type of criminal cases were filed at Justice Court as misdemeanors would cause an increase at the District Court caseload. This may create a need for more staff to handle increase caseload and potentially impact costs for appointed counsel because of more time spent in Court. Also might increase jury costs if they go to trial on a regular basis. The estimated fiscal impacts are difficult to determine at this point.

Comment: Adds provisions to NRS 33.100 that would make violating a temporary protection order (TPO) a gross misdemeanor (currently a misdemeanor) and violating an extended TPO a category C felony (currently a misdemeanor).

The impact would be measured in inmates spending additional time in custody. In 2016, the average length of stay (ALOS) for misdemeanors = 8.6 days, gross misdemeanors = 24.0 days, and felonies = 43.3 days.

In 2016, DSD booked 121 TPO and 61 extended TPO violators. At the DSD FY16 average daily bed rate (\$155/day/inmate), the increase in length of stays associated with the greater penalties would = \$617K/year fiscal impact.
