Materials are the biggest fiscal impact to the new class. Books are about \$100 a book. In any given class, we have approximately 5000 students. So, the fiscal note for materials would be \$500,000.

Teacher training would require 1-2 days of training for the 1-2 teachers from each school teaching the class. This would be stipend pay at \$30 an hour x 15 hours = \$13,500.
