BDR 40-889 provides for the licensure and regulation of tanning beds, lasers and other forms of non-ionizing radiation, which will have a fiscal impact to the Division.

Staff training, and the development of the inspection program and related regulations will require the Division to hire one supervisor and five inspectors effective October 1, 2017. An Administrative Assistant will be hired effective January 1, 2018. In addition to personnel and related costs, special laser radiation detection equipment will be required.

The Radiation Control Program has estimated that approximately 2,200 devices would need to be regulated.
