City/County: Clark County Approved by: David Dobrzynski, Asst Director of Finance Comment: This proposed bill requires District Court to establish an independent review panel to observe all domestic relations proceedings for the purpose of ensuring that judges are acting impartially and appropriately. This bill also requires District Court to establish advocate group to provide assistance to veteran who is a party to a domestic relations proceedings and to establish a program that require a peace officer to supervise the exchange of a child for custody hearings. The District Court is required to establish an independent panel and advocate group not later than October 1, 2017. Family Court will also need to establish a said program as soon as practicable but not later than January 1, 2018. Undeterminable. The proposed bill did not indicate as to how this independent panel and advocate group will be compensated with their services.
