Comment: Any form of compensation must be collectively bargained pursuant to NRS 288.150. In order to get around this issue, the State has intermittently created incentive programs that have allowed school districts to offer signing bonuses. The District has assumed that this BDR will offer compensation in a similar format. If this is the case, then the District can expect to replace approximately 2 teachers each year that would qualify for this incentive. This figure is based on prior year employee turnover ratios. If we assume that the incentive is equal to of \$2,500 per person is sufficient to attract new employees, then the District can expect to apply for and pay approximately \$2,606 including reimbursement for payroll related expenses. In addition, the District would include funding to attend job fairs in other states to recruit the most qualified candidates that meet the unique lifestyle of rural Nevada.
