Comment: BDR 19-560 makes various changes to the Nevada Public Records Law, including various requirements of state governmental entities. The Nevada Commission on Ethics is a state governmental entity subject to the Public Records Law, with various exemptions for certain confidential materials.

This bill will impose a duty on the Commission to provide copies of its public records in electronic format, unless requested otherwise. The bill further requires a response to public records requests within certain timeframes and authorizes the Commission to provide notice of additional time to respond and to charge certain fees for extraordinary use of personnel or technological resources.

Under the Commission's current practices, the Commission maintains all of its records electronically, and most, if not all, requests for public records are provided in electronic format. Given the small staff of the Commission, a significant public records request could be given additional time, with appropriate notice to the requester, and authorize certain fees for public records used for commercial and non-commercial requests. The bill inherently imposes an additional requirement on the Commission to determine whether a request for its public records is for commercial purposes to determine whether a fee is appropriate. It also begs the question whether the request is originally intended for commercial purposes versus whether the information is ultimately used for commercial purposes. This aspect of the bill may present fiscal considerations in terms of staff time and resources attributed to responding to public requests and when/if that extraordinary time can be reimbursed through fees, but that is speculative at this juncture. Given the Commission's current practice of maintaining electronic records, responding in an electronic format, and requesting additional time when necessary, these amendments to the Law do not create any increased fiscal impact on the Commission.
