Comment: BDR 38-858 requires Medicaid and all insurance plans to provide certain contraception benefits. Some of these benefits are required as part of the Affordable Care Act (ACA), which means they do not really need to be state law (unless there is concern that those benefits will be eroded at the federal level). There are also some extra requirements that circumvent procedures insurance companies use to try to control prescription costs. Changing the term "contraceptive" to "hormone replacement therapy", may open up the requirements for insurance companies to cover costs for items they currently do not cover. If BDR 387-858 were to pass, it is difficult to determine the fiscal impact to local government, however, if there are requirements for insurance companies to cover prescription drugs that they may not otherwise, we would anticipate these costs to be passed on in the form of medical premium increases of approximately 1% – 2% percent per year. A 1% increase to Churchill County's insurance premiums is equivalent to \$17,141. We estimate the fiscal impact between \$17,000 to \$34,000 per year.

Comment: The Affordable Care Act requires certain contraceptive drugs, devices and services to be covered by every health insurance plan without charging copays, coinsurance or a higher deductible. This bill would make those requirements Nevada law. It would require coverage of additional forms of contraception, including up to a 12-month supply of contraceptives or a therapeutic equivalent, insertion or removal of a contraceptive device and voluntary sterilization for men and women. A health insurance plan would no longer be allowed to require a program of step therapy or prior authorization for benefits included in this bill.

It is estimated the additional cost of providing the benefits included in this bill would be 0.2% per year. Since this bill would not be in effect until January 1, 2018, there will be no fiscal impact for the remainder of FY2017. Utilizing 2016 claims data and adjusting for inflation and the rising cost of health care, the total fiscal impact from the effective date of this bill through the end of FY2019 (18 months) would be nearly \$236,000.
