## Local Government Responses A.B. 267 / BDR 53 - 650

School District: Clark County School District

Comment: Per NRS the CCSD's School Police employees do not qualify for coverage under this bill. However, if they were ever to be included as a "police officer" under this bill, we would have a fiscal impact with the proposed changes. In Section 1, calculating hours missed versus days would be extremely time consuming and would probably require us to hire another FTE to track this information. The Section 4 provision of paying claimant's attorney fees to fight a denial of coverage would open us up to unmanageable legal costs that would be difficult to budget.

Comment: BDR 53-650 relates to police-fire workers compensation for heart and lung disease. If this bill were to pass it would require the employer to pay an employee's attorney fees and expenses if the employee prevails in a worker's compensation case. It also restricts to whom the employees' annual heart and lung physicals may be disseminated - for example, Churchill County uses an outside agency to review the physicals and writer letters to the employees. If passed, this BDR would have some minor fiscal impact to the County. This type of claim does not arise too frequently in Churchill County, but all sworn law enforcement employees are covered under this bill, so there is potential for a more significant impact, depending on the number of employees who submit heart-lung claims.

Comment: This bill revises provisions relating to industrial insurance and the payment of compensation for temporary or permanent disability or death resulting from the occupational diseases of lung disease, heart disease or cancer for firefighters, arson investigators and police officers. Under provisions of this bill, if an employer denies a claim for compensation for these occupational diseases and the claimant ultimately prevails, the employer will be required to pay the claimant's attorney's fees and associated costs. Additionally, under current law, no compensation may be paid for an occupational disease which does not incapacitate the employee for at least 5 cumulative days within a 20-day period. This bill would make claims for compensation for the occupational diseases of cancer, lung disease and heart disease exempt from that prohibition.

5-Day Rule Exemption: Based on claims experience, it is estimated Clark County denied \$1.07 million worth of claims in 2016, which likely would have been approved under this provision. Adjusting for trends in the State's average weekly wage used for computing maximum disability compensation, it is estimated these claims would be worth \$1.11 million in FY2018 and \$1.11 million in FY2019.

Comment: This bill could have a significant fiscal impact on the City of Las Vegas, but we are unable to fully quantify without further detailed analysis.

Additionally, this BDR requires that the Insurer/Third Party Administrator pay attorney fees and associated costs if a claimant prevails on a claim denial. There are several issues regarding this that could lead to fiscal impacts: A) Claimant attorneys currently have no cap on fees, therefore they could be double dipping on the front end, as well as the back end (when they receive a portion of the claimant's Permanent Partial Disability); and B) there is no reciprocity in this to reimburse the insurer if the City should prevail.

If the City of Reno's Workers' Compensation TPA denies a "presumptive" claim from a Firefighter or Police Officer, and that denial is overturned through the Workers' Compensation appeals process, according to this BDR, the City would then be on the hook for all fees and costs associated with that Firefighter or Police Officer's legal case to fight the denial. This could potentially be a big cost, however it's difficult to estimate because the City does not often have denied "presumptive" claims.
