Section 20 requires the Division to annually provide training to all the employees of the Department of Public Safety, all the employees of local enforcement agencies, all peace officers, firefighters and emergency medical attendants and all treatment providers and persons involved in providing instruction or treatment as part of a court-ordered treatment program on the rights granted to a person who holds a medical marijuana registry identification card or letter of approval. With assistance from the Department of Employment, Training and Rehabilitation and the Department of Public Safety, the Division estimates this would require training for over 23,000 individuals annually.

To develop and maintain a training program for this many individuals, the Division believes it would take one Education and Information Officer, one Program Officer I and one Administrative Assistant II. Personnel and related operating costs would be approximately \$231,192 in FY 2018, \$226,869 in FY 2019 and \$479,614 for the FY 2020/21 biennium. Please see Exhibits 1 and 2.

The Division estimates it would cost \$90,000 for the first year and \$20,000 per year thereafter for maintenance costs for a training management system.
