Assembly Bill No. 130—AN ACT relating to guardianships; authorizing a court to require a proposed guardian to file a proposed preliminary care plan

and budget; establishing the process by which an attorney may obtain the approval of the court to receive compensation from the assets of a ward for certain services; establishing the Office of the State Public Guardian; replacing the term "incompetent" with the term "incapacitated" for purposes of guardianships and revising the definition thereof; revising various provisions relating to notice given to certain persons; revising provisions concerning the sale of real and personal property of a ward; and providing other matters properly relating thereto.

Assemblywoman Benitez-Thompson moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 133—AN ACT relating to real property rights; prohibiting adverse action against certain persons for requesting emergency assistance on a rental property in certain cases; specifying that a request for emergency assistance on a rental property does not constitute a nuisance in certain circumstances; and providing other matters properly relating thereto.

Assembly Bill No. 134—AN ACT relating to local government finance; increasing the limit on the amount of annual total expenditures for a special district to be eligible to petition for an exemption from certain requirements

Assembly Bill No. 135—AN ACT relating to public safety; revising provisions relating to prohibited acts concerning the use of marijuana and the operation of a vehicle or vessel; and providing other matters properly relating thereto.

Assemblywoman Benitez-Thompson moved that the bill be referred to the Committee on Judiciary.

By Assemblywoman Neal:

Assembly Bill No. 136—AN ACT relating to criminal procedure; providing that certain defendants must be admitted to bail on an unsecured bond; and providing other matters properly relating thereto.

By Assemblywoman Carlton:

Assembly Bill No. 137—AN ACT relating to taxation; revising provisions governing the total amount of transferable tax credits that may be approved by the Office of Economic Development pursuant to applications submitted to the Office by a producer that produces a film, television or other visual media production in this State; eliminating provisions that cap and repeal the tax credits that an insurer may take against the general tax on insurance premiums; and providing other matters properly relating thereto.

elementary school; requiring a competitive grant program to be created to provide grants of money to public elementary schools for establishing programs of dual language immersion; making appropriations; and providing other matters properly relating thereto.
