Assembly Bill No. 234—AN ACT relating to motor carriers; requiring certain motor carriers of passengers which transport certain persons with disabilities to ensure that each vehicle used for the transport is equipped with first-aid equipment and each driver of the vehicle receives training in first-aid and cardiopulmonary resuscitation; providing a penalty; and providing other matters properly relating thereto.
