Assembly Bill No. 244—AN ACT relating to insurance; authorizing certain types of insurance and insurers to give certain items and gifts not to exceed \$100 in aggregate value per policyholder or insured or prospective policyholder or insured in any 1 calendar year; and providing other matters properly relating thereto.

Assemblywoman Bustamante Adams moved that the bill be referred to the Committee on Commerce and Labor.

By Assemblywoman Benitez-Thompson; Senators Kieckhefer and Parks:

Assembly Bill No. 245—AN ACT relating to pharmacy; requiring a pharmacist or his or her designee to make certain entries any time a biological product is dispensed under certain circumstances; requiring the dispensing of an interchangeable biological product in substitution for a prescribed biological product under certain circumstances; requiring the State Board of Pharmacy to maintain lists of approved interchangeable biological products on its Internet website; providing a penalty; and providing other matters properly relating thereto.

Assemblywoman Benitez-Thompson moved that the bill be referred to the Committee on Commerce and Labor.
