Remarks by Assemblyman Carrillo.

ASSEMBLYMAN CARRILLO:

Assembly Bill 85 removes a condition that requires instruction in cardiopulmonary resuscitation techniques and the use of an automated external defibrillator be provided as part of a course of study in health taught to pupils in public and private secondary schools only to the extent money is available for that purpose, thereby making such instruction mandatory. This bill is effective on July 1, 2017.

This is a bill that was brought to ensure that our younger students in school are able to have just the basic understanding of the things that I mentioned in the summary. This personally affected me when I was in high school because I was able to assist in resuscitating my own mom when I was in high school. I know how important this would be to help our younger students that may come across this. We had testimony to that effect, somebody that saved their father. I would really ask the body to pass this bill.

The bill also prohibits a business that accepts a driver's license or identification card issued by Nevada's Department of Motor Vehicles from refusing to accept a permanent resident card for the same purpose.

REMARKS FROM THE FLOOR

Assemblyman Wheeler requested that the following remarks be entered in the Journal.

ASSEMBLYMAN EDWARDS:

America was born in revolution. Through the amazing patriotism of the colonial soldier and sailor, these United States were created. For 240 years, patriots of every generation have heeded the call for military service in defense of our republic—240 years of dedication, sacrifice, and unswerving commitment to the ideals of this great nation. In times of war and of peace, those we call veterans rose to face dangers known and unknown, protected our citizens, and preserved our way of life.

Only 10 percent of Americans today can claim the title of veteran. Since the horrific terrorist attacks of September 11, only 1 percent of our population has worn the country's uniform. Currently, less than 1 percent of our citizens are defending us in the Global War on Terrorism. To paraphrase Winston Churchill, never have so many owed so much to so few.

It is perhaps very fitting that today, as we celebrate Veterans and Military Day at the Nevada Legislature, we remember our state nickname, Battle Born. For like America, the Silver State was born in war, indeed the bloodiest and most horrific in our history. Our veterans have lived up to the state motto All for Our Country ever since, serving around the world in every conflict. Indeed, 894 have made the ultimate sacrifice for our country, their families, this state, and for us.

What we rarely hear about are the sacrifices made by the families of military service members and veterans. While those on active duty carry out their responsibilities during their deployments, families must soldier on during holidays, anniversaries, school plays, and all those invaluable moments, absent their loved ones. Most will tell you that their families are their heroes. As we honor our veterans and military service members today, let us take a moment to say thank you to those loved ones who are so left behind.

While we express our appreciation for the service and sacrifices freely given by our soldiers, sailors, airmen, marines, and veterans, let us make sure that this Legislature provides them the means to take care of themselves and their loved ones. Let us dedicate our time here in the legislative session to doing the right things for those who have done so much right for us. We owe that to Nevada's 300,000 service members and veterans.

Please join me in thanking the military service members and veterans here today, those around the Battle Born State, and especially those stationed or deployed on foreign shores for their service, sacrifice, dedication, and love of country.

ASSEMBLYMAN OSCARSON:

It is my distinct honor and privilege to have with me today Mr. Gil Hernandez, Mr. Frank Reynolds, and Brigadier General William Burks. Mr. Reynolds and Mr. Hernandez are both Purple Heart recipients.

With your permission, Mr. Speaker, I would like to give some brief remarks. This Proclamation of the Nevada Legislature designates the state of Nevada as a Purple Heart State. It strongly encourages Nevadans to honor Purple Heart recipients and honors the service and sacrifice of the nation's men and women in uniform wounded or killed by the enemy while serving to protect our freedoms.

The Purple Heart is awarded to members of the armed forces who are wounded or killed in action as a result of enemy activity. The Purple Heart is the oldest known military decoration in the United States that continues to be used and was created as the badge of Military Merit by General George Washington. To honor combat-wounded veterans for their service and sacrifice,

several states have designated their states as Purple Heart States. Today we honor Purple Heart veterans by designating Nevada as a Purple Heart State.

Gentlemen, it is one of my most distinct honors and privileges to present this to you.

ASSEMBLYMAN KRAMER:

I am a veteran of the United States Army. I volunteered at a time when many were leaving the country to avoid being drafted. While I was trained for and expected to serve in Vietnam, I served in the United States and Korea. I believe that the United States military is by far the most prejudice-free, merit-based organization on earth. It used to be that the Army would take someone who was given the choice of jail or military service—not any more. Today you have to be a high school graduate and actually have references. The Army wants trainable recruits who can learn to work a high-tech job. The Army is also a place where an economically disadvantaged person can go to learn a skill and, perhaps more important, save money for college. I am proud of my service and will encourage my grandchildren to serve. Please join me in giving thanks to our veterans and I ask you to remember that all gave some, but some gave all.

Assemblyman Wheeler requested that the following proclamation be entered in the Journal.

PROCLAMATION

WHEREAS, The residents of the State of Nevada have great admiration and the utmost gratitude for the men and women who have served our country and this State in the Armed Forces of the United States, selflessly making personal sacrifices to defend our freedom, leaving their families and homes, and placing themselves in harm's way for the good of all; and

WHEREAS, The courage of these men and women who have served in the Armed Forces has been fundamental to maintaining the freedom and quality of life enjoyed by our citizens; and

WHEREAS, The Purple Heart is the oldest known military decoration in the United States that continues to be used and was created as the Badge of Military Merit by General George Washington on August 7, 1782; and

WHEREAS, The Purple Heart is specifically a combat decoration, awarded to members of the Armed Forces of the United States who are wounded by an instrument in the hands of the enemy, and posthumously to the family members of those who were killed in action, who died of wounds received in action or who died as prisoners of war while in captivity; and

WHEREAS, Since 1864, there have been 894 residents of this State awarded the Purple Heart for giving their lives in armed combat, and many more who have been awarded the Purple Heart for wounds received in combat; now, therefore, be it

PROCLAIMED, That the members of the 79th Session of the Nevada State Legislature do hereby designate the State of Nevada to be a Purple Heart State; and be it further

PROCLAIMED, That the members of the 79th Session of the Nevada Legislature hereby acknowledge with gratitude the service of and sacrifices made by the men and women in uniform who have been wounded or killed by the enemy while serving to protect our freedom; and be it further

PROCLAIMED, That the members of the 79th Session of the Nevada Legislature strongly encourage all Nevadans to remember and honor the recipients of the Purple Heart.
