#### GENERAL FILE AND THIRD READING

Senate Joint Resolution No. 2.

Resolution read third time.

Remarks by Assemblymen Ohrenschall, Diaz, Titus, Hansen, Tolles, and Carlton.

#### ASSEMBLYMAN OHRENSCHALL:

Senate Joint Resolution 2 ratifies the Equal Rights Amendment [ERA] to the *United States Constitution*. This resolution provides that the Secretary of the Senate must prepare and transmit a copy of S.J.R. 2 to the Secretary of State, who shall keep it as a record of acts of the Legislature. The Secretary of the Senate shall also transmit a certified copy to the Archivist of the United States and a copy of S.J.R. 2 to the Vice President of the United States, the Speaker of the House of Representatives, and each member of Nevada's Congressional Delegation.

I think what we are doing today is one of our most awesome responsibilities. We are proposing to amend the *U.S. Constitution*. This is something that spans more than 40 years, and it is a historic moment for us. When I was trying to decide what to say today under Order of Business 15, I really thought that we have to ask ourselves one question: When is a woman equal to a man? Many of us here were raised by single moms—I grew up knowing when the rent was due. The landlord does not care if it is a woman or a man who has to pay the family's rent. The landlord believes the woman is equal to a man. When the light bill is due, the light company believes a woman is equal to a man when they want that payment. When groceries need to be bought for the family, the supermarket does not care if it is a man or a woman. They are every bit as equal as long as they can buy those groceries. The Equal Rights Amendment will enshrine in our *Constitution* that there is no question that women are equal to men and able to enjoy the same rights that all of us enjoy. I urge this body to pass Senate Joint Resolution 2.

#### ASSEMBLYWOMAN DIAZ:

I rise today in strong support of Senate Joint Resolution 2, a resolution that ratifies Nevada's support for the Equal Rights Amendment. Opponents of this resolution argue that the time for ratification has passed and that the protections that this ratification would provide are already covered in the *Constitution*. If these are the only two arguments against the resolution, then I do not see how it does not pass out of this body 42 to 0. As we have discussed in our Legislative Operations and Elections Committee and as others have mentioned before, it is up to Congress to decide whether or not the ratification deadline has effectively ended the chance of ERA passage nationwide. If the protections are already piecemeal in the *Constitution*, then why not enshrine them there to ensure all of these equality measures are in place and we are all truly covered?

Mr. Speaker and colleagues, 97 years after women gained the right to vote, we still do not have equality in our state or in our country. We still do not have equal representation in government, and women earn less on the dollar than men. This is why we need the passage of this resolution. There are forces out there that want to stand in the way of progress and stand in the way of equality instead of simply doing the right thing—voting for passage of this resolution and showing the nation and citizens of our state that we stand for equality.

We need passage of this resolution for every constituent of ours who currently earns less than a male counterpart in her office, 79 cents on each dollar. We need passage of this bill for

women of color. We live in a nation that somehow still sees Hispanic or Latina women make 54 cents on the dollar compared to a white man, and black women make 64 cents on the dollar compared to a white man.

This resolution is symbolic and not in a bad way. It is not being used purely for symbolism. This resolution is a symbol to our constituents and state that enshrines in our *Constitution*, with so many other inalienable rights, that being a woman is not less than or more than a man, but is equal to a man. And beyond symbolism, Mr. Speaker, if this resolution spurs the adoption of the ERA nationwide, we will see some very practical implications. The ERA would provide a judicial standard when it comes to cases of sex discrimination, and it would strengthen the 14<sup>th</sup> Amendment to allow us to see that amendment grant equal rights on the basis of sex. Lastly, the ERA would provide attorneys a stronger legal defense against the attempted rollback of women's rights that we are seeing in other states in our nation and ensure that does not happen here in Nevada.

Mr. Speaker, for every woman, and more so for every Nevadan, I rise in full support of S.J.R. 2 and hope to see my colleagues support it wholeheartedly as well. This vote is for the former Honorable Jean Ford, Sue Wagner, and the men and women who have been fighting for equal rights for what seems like forever.

#### ASSEMBLYWOMAN TITUS:

I rise today deeply disturbed by the political theatrics that this body is seemingly always engaged in. Hardly a week goes by that this Assembly is not casting some symbolic vote or a vote on some piece of long-settled social legislation. As for myself, I abhor any kind of discrimination, be it gender, skin color, or sexual orientation. I believe that most Nevadans feel the same way I do.

After an election cycle where we saw a female for the first time with the nomination of a major party for President and then saw a record number of women elected to this body, let there be no doubt that the role of women in America is settled in 2017. It is settled as law; it is settled in the values we hold dear as Nevadans.

I will be voting no, not because I do not believe that the ERA should have been passed 30 years ago, but because I do not believe that my constituents sent me here to cast symbolic votes with no promise of success. They sent me here to create an environment that fosters high-quality and high-paying jobs, safer streets, better education, and a government accountable to the people. For those reasons and many more, I urge my fellow members to vote no.

#### ASSEMBLYMAN HANSEN:

I rise in opposition to Senate Joint Resolution 2. I would like to give the body an explanation of what my amendment was actually about, because as most of you already know, this is a pretty old issue. In 1978, this exact question was on the Nevada ballot and the citizens of our state voted overwhelmingly, 2-to-1, against passage of the Equal Rights Amendment. What my amendment, which was just voted down on a party-line vote, did was to, once again, take this proposed amendment and place it before the voters of the state of Nevada to see if, in fact, as the proponents of this have suggested, Nevada has changed so much. Why exactly we would want to not allow the citizens of our state an opportunity to vote on such a critical issue, I do not quite understand.

Just a little, quick background on the actual historical facts behind this—in 1982, June 30, 1982, the deadline for the ERA passed. It did not pass at that time. The National Organization for Women sued the state of Idaho over this, and the United State Supreme Court ruled that the Equal Rights Amendment was dead. It was moot at that point in time. So if we want to, in fact, resurrect the Equal Rights Amendment, what we are doing here is purely symbolic because the courts have already ruled that this amendment is dead. The process to have an amendment has to start in the United States Congress, or we as a body have to call for a state convention to actually propose an amendment to the *Constitution*. So I think we need to understand that. The proponents will say What about the fact that some people claim there is a legal doctrine that would allow it to be resurrected. That is found in *Coleman v. Miller*, a 1939 Supreme Court case. In that court case, the United States Supreme Court did, in fact, say that when there is an amendment proposed to the *Constitution*, there is no cap on the time-frame unless Congress had

specified that there was. In this case, Congress clearly did. The original deadline of the Equal Rights Amendment was 1979, and they extended it to 1982 and it still failed.

So while I appreciate the symbolism, the reality is this: The Equal Rights Amendment is a tremendous transfer of power from the states to the United States federal government—the last thing we need in Nevada. Virtually every single issue that has been addressed as far as inequality and sexual discrimination is now found in statute in the state of Nevada. All of the issues that have been addressed in front of the Legislative Operations and Elections Committee and so forth are already in statute. If you are being discriminated against in your pay and you are a female and your employer is deliberately paying a male more than you with the same amounts of seniority and so forth, you have a fantastic legal case under Nevada's existing law.

Mr. Speaker, thank you for indulging me. I would urge all my colleagues who really love the process and believe that an amendment to the *United States Constitution* is something extremely serious, and that we should follow the procedures that our Founding Fathers laid out in the Constitution—I would urge all of those folks to vote no on Senate Joint Resolution 2.

#### ASSEMBLYWOMAN TOLLES:

Thank you Mr. Speaker. I rise in support of Senate Joint Resolution 2. In November of 1916, 100 years before every legislator in this body was elected for this term of office, Republican Jeannette Rankin was elected as the first female to Congress. Just three years later in 1920 women around the United States won the right to vote. There were two primary arguments behind the movement for women's suffrage. One group claimed that there were no differences between men and women and they should be treated exactly alike. Another group advocated that although men and women were similar in many ways, there were inherent differences and that what was missing in American politics was the female voice to help the country focus on issues that would otherwise be ignored. These were two vastly different perspectives and approaches. You might say that one was liberal and one was conservative, but they were both able to come together around the common goal of fighting for a woman's right to use her voice and her vote.

Fast forward to the 1970s and a new conversation began about whether or not women were of equal worth in the workplace. In the 1970s my mom was a single mom working hard during the day for my brother and I. She worked hard at night studying for her Series 7, and eventually she became one of the first female stockbrokers in the male-dominated industry in a large national firm. A few years ago when the popular TV show Mad Men came out, people would ask her if she watched it and she said, "I don't have to. I lived it,"

We have come a long way since then. In fact, Nevada was at the forefront of the fight for women's rights in many regards, passing over two dozen antidiscrimination laws, essentially fulfilling the goals of the Equal Rights Amendment at the statutory level. But as of today, in 2017, there is a still a gap. Nevada is one of only nine, yes nine, states that has not voted for an equal rights amendment either on the federal or state level. Over the past 45 years, 35 states voted for the ERA to be ratified into the *U.S. Constitution* and 24 states went further to pass a version of their own into their state constitutions.

I will confess to you that I hesitated on this vote today. I am conservative; I am cautious about overly cumbersome burdens on business, and most importantly, I am committed to fighting for the rights of unborn future women and men. I know there are strong convictions and feelings about these topics, and I hope we can continue to have those debates in respectful and factual ways. But as I surveyed the past 45 years after 41 states have voted for some form of ERA, I am convinced that many of the fearful consequences that have been presented over these past few weeks by and large have not nor will they occur. In fact, there have been over 300 prolife laws passed in the last eight years alone, most in states that voted for the ERA.

The second reason I hesitated was because the deadline for the ERA passed over 35 years ago, as has been pointed out, and according to a 1982 *U.S. Supreme Court* order, it has been deemed moot. So why vote for something that some would argue is purely symbolic? I would argue this Chamber is full of symbolism. On my left hand I wear a ring that symbolizes my promise to love, respect, and stay faithful to one man for the rest of my life. We stand underneath a seal that reminds us we are a Battle Born State and that Home Means Nevada, and

we pledge allegiance to a flag every single day to celebrate the freedom that was so hard fought for.

Forty-four years ago my predecessor, Sue Wagner, who is here with us today—served in Assembly District 25, then Senate District 15, and then went on to be the first female Lieutenant Governor in Nevada—fought hard for the Equal Rights Amendment. Out of gratitude and respect for her and the countless others who have fought for women to have an equal voice and equal value, and for my daughters and the generations to come, I stand in support of the declaration that the state of Nevada values both men and women equally. Thank you.

#### ASSEMBLYWOMAN CARLTON:

I rise today in support of Senate Joint Resolution 2. I started my political career on the Equal Rights Amendment. Back in the early '70s I was in high school—you know you do not worry about telling people your age once you get elected to office because it becomes part of history, so you do not even bother to try and hide it anymore. Mr. Speaker, I came from a mixed family at home. My mother was a Democrat, my father was a Republican. We were Irish-German so the dinner table was always a very lively place to be, and my friends would always want to come and listen to the debate we had. I remember wearing my ERA button to the dinner table one night. It was not a real smart move on my part. So we had a real long conversation about that, and I remember my mother wrapping up the conversation after everybody had had their say. She told the story and reminded my father about how she had to take her wedding ring off to go to work because married women could not keep their jobs. She had a very good job in south St. Louis working for a very well-known company, but once you got married, you were asked to leave because you were probably going to have a baby. They did not want married women. At that time, my mother made more than my father, so they made the decision, and every day on the streetcar when she went to work, she took her wedding ring off, she put it in a tissue, and she put it in her coin purse. That ring of symbolism she had to remove in order to keep her job because she wanted a house for her children, and that is how they were going to get a house.

Time went by and eventually my mother became pregnant with me. I am the oldest of five. It was time to tell her employer that she had to go. Her employer felt bad about it, did not want it to happen. It did not stop them from firing her though. There is no reason why someone who is perfectly capable of doing a job, very good at it, very dedicated, should be asked to leave their employment and should not be allowed to wear that symbol every day to show the love that she and my father had.

I vote for this today in honor of my mother, my grandmother, and my two daughters. I got elected to this body so that this will not happen any longer. Symbolism or not, it is time to send the message.

applicant or for rescission of a conditional offer of employment in the unclassified or classified service of the State only after consideration of certain factors relating to the criminal history of the person; providing for written notice to a person if the criminal history of the person is the basis for the Administrator's refusal to certify the person or for the rescission of a conditional offer of employment; establishing similar provisions relating to the consideration by the governing body of a county or incorporated city of the criminal history of an applicant for employment by a county or incorporated city; and providing other matters properly relating thereto.
