GENERAL FILE AND THIRD READING

Senate Bill No. 7.

Bill read third time.

Remarks by Senator Hardy.

Senate Bill No. 7 removes the requirement that a person must be in a duty status, instead requiring that the person was subject to jurisdiction under certain provisions of the Nevada Code of Military Justice, in order to be tried or punished for certain offenses under the Code. The bill further provides that any person who is subject to the Code commits the offense of waste, spoilage or destruction of property, other than military property, regardless of whether the person was in a duty status at the time he or she committed the offense. This bill further clarifies changes made to the Code in the past two Sessions by Senate Bill 18 of the 77th Session and Senate Bill 90 of the 78th Session.

Bill read third time.

Remarks by Senator Ratti.

Senate Bill No. 58 revises provisions governing certain State veterans' organizations. Specifically, the bill: adds the Administrator, Division of Human Resource Management, Department of Administration, as a member of the Interagency Council on Veterans Affairs; requires the Director and Deputy Director of the Department of Veterans Services to aid, assist, encourage and cooperate with certain State veterans' service organizations, and increases from 9 to 11 the number of members of the Nevada Veterans Services Commission by adding: a member who is a member of the Women Veterans Advisory Committee, and a member who is enrolled as a student at an institution of higher education in this State in a program for a baccalaureate or higher degree and who possesses an honorable discharge from some branch of the military and naval service of the United States.

We heard testimony that the Commission wanted to expand and be more inclusionary. I make this motion in honor of my cousin, Sheri Masini, who is a 26-year veteran of the Air Force. When she returned and enrolled in school, she shared with me she had a difficult time connecting with veterans' organizations. This is a great step forward.

Senate Bill No. 70.

Bill read third time.

Remarks by Senator Goicoechea.

Senate Bill No. 70 expands the entities to which the Director of the Department of Veterans Services is authorized to transfer abandoned or unclaimed property to include the Nevada State Museum, the Nevada Historical Society and any other governmental agency or nonprofit entity, including without limitation, a veterans' organization and the United States Department of Veterans Affairs. The measure authorizes the Director to destroy, or otherwise dispose of, such property that is not transferred. The Director must establish and post on the Department's website an internal policy regarding the transfer, destruction or other disposal of such abandoned or unclaimed property.

Many of these are small items that are left at shrines, statues or places like the Vietnam Memorial. They may have some significance, but, like the comment made at one of the Committee meetings about how many Singer sewing machines you can have at the Nevada State Museum, you can only have so many in one place. This allows the Director to try to give these items away without having to dispose of them. If they cannot do anything else, in the end, they have the right to dispose of them.
