INTRODUCTION, FIRST READING AND REFERENCE

By the Committee on Commerce, Labor and Energy:

Senate Bill No. 226—AN ACT relating to transportation network companies; prohibiting a transportation network company from allowing a person to be connected to potential passengers using the digital network or software application service of the company unless the person holds a valid state business registration; requiring a driver to submit to a transportation network company certain information relating to his or her state business registration; requiring a transportation network company to periodically report

certain information relating to drivers affiliated with the company; and providing other matters properly relating thereto.

Senator Atkinson moved that the bill be referred to the Committee on Commerce, Labor and Energy.

Motion carried.

By Senators Woodhouse, Manendo, Parks, Ford, Spearman, Cancela, Denis, Ratti, Segerblom; Assemblymen Carlton, Oscarson and Titus:

Senate Bill No. 227—AN ACT relating to nursing; authorizing a qualified advanced practice registered nurse to sign, certify, stamp, verify or endorse certain documents requiring the signature, certification, stamp, verification or endorsement of a physician; authorizing an advanced practice registered nurse to make certain certifications, diagnoses and determinations required to be made by a physician or other provider of health care; providing penalties; and providing other matters properly relating thereto.

Senator Woodhouse moved that the bill be referred to the Committee on Commerce, Labor and Energy.

Motion carried.

By the Committee on Health and Human Services:

Senate Bill No. 228—AN ACT relating to the medical use of marijuana; authorizing the issuance of a registry identification card or letter of approval to engage in the medical use of marijuana for certain patients who suffer from opioid addiction; authorizing additional providers of health care to provide the written documentation necessary for such a patient to obtain a registry identification card or letter of approval; and providing other matters properly relating thereto.

Senator Spearman moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Senator Harris:

Senate Bill No. 229—AN ACT relating to guardians; establishing a form by which a person may request to nominate another person to serve as his or her guardian; revising provisions governing registered agents to authorize a person to serve as a registered agent for a nonresident guardian; revising provisions relating to the Nevada Lockbox to include forms requesting to nominate a guardian; and providing other matters properly relating thereto.

Senator Harris moved that the bill be referred to the Committee on Judiciary. Motion carried.

By the Committee on Judiciary:

Senate Bill No. 230—AN ACT relating to judgments; increasing the percentage of a judgment debtor's disposable earnings which is exempt from execution under certain circumstances; authorizing a judgment debtor who is a resident of this State to bring a civil action in certain circumstances against

a judgment creditor who obtains a writ of garnishment without domesticating a foreign judgment; extending the period for which a writ of garnishment served on an employer of a judgment debtor continues; and providing other matters properly relating thereto.

Senator Segerblom moved that the bill be referred to the Committee on Judiciary.
