Senate Bill No. 330—AN ACT relating to professional licensing; establishing certain standards against which governmental entities and regulatory bodies are required to review regulations relating to entry into businesses and professions and certain restrictions on the provision of public services; authorizing a natural person to petition a governmental entity or regulatory body to request the amendment or repeal of such regulations; authorizing a natural person to appeal a denial of such a petition to the district court; and providing other matters properly relating thereto.

Senate Bill No. 345—AN ACT relating to economic development; requiring an applicant for a partial abatement of certain taxes to create a statement of the fiscal impact of the abatement on each affected county, city or school district and obtain the recommendation of the board of county commissioners of the county in which the project will be located; requiring the State Plan for Economic Development to include a 5-year business plan for the State; requiring the Legislative Auditor, as directed by the Legislative Commission, to conduct an audit of certain recipients of economic development incentives; revising the requirement for the tax expenditure report submitted by the Executive Director of the Department of Taxation; and providing other matters properly relating thereto.
