

**MINUTES OF THE
SENATE COMMITTEE ON COMMERCE, LABOR AND ENERGY**

**Seventy-ninth Session
April 14, 2017**

CHAIR ATKINSON:

I will open the work session on Senate Bill (S.B.) 235.

SENATE BILL 235: Provides for the regulation of ticket sales to an athletic contest or live entertainment event in certain circumstances. (BDR 52-672)

CHAIR ATKINSON:

I believe Senator Woodhouse is okay with the amendments.

MIKE SCHNEIDER:

Senator Woodhouse is okay with the amendments she proposed.

CHAIR ATKINSON:

Is she okay with the other amendments?

MR. SCHNEIDER:

Yes.

SENATOR GANSERT:

I am concerned about the penalties in this bill. The \$1,000 threshold seems fairly low. I also want to make sure the secondary market is still open. I had heard this bill could preclude ticket resales.

MR. SCHNEIDER:

The secondary market remains open. We thought the \$1,000 threshold was appropriate because individuals selling more than \$1,000 in tickets are professionals in the secondary market.

SENATOR GANSERT:

It does not take that many tickets to reach \$1,000.

SENATOR SETTELMAYER:

Was there any discussion regarding three separate offenses? To me, the penalty should include three strikes. I worry about one offense constituting a felony.

CHAIR ATKINSON:

We have already discussed this issue, and Senator Woodhouse chose not to address it.

SENATE BILL 253: Establishes the Nevada Pregnant Workers' Fairness Act to provide protections to employees who are affected by any condition relating to pregnancy, childbirth or a related medical condition. (BDR 53-773)

MS. PASLOV THOMAS:

I will read the summary of the bill and proposed amendments from the work session document ([Exhibit H](#)). Senator Cannizzaro submitted two additional conceptual amendments ([Exhibit I](#)).

SENATOR HARDY:

I have a challenge with one of the amendments from the standpoint of the Health Insurance Portability and Accountability Act (HIPAA) of 1996. I do not want medical information to be shared in an unsecure way. I am reluctant to include the amendment relating to the request for medical documentation because of the unsecure place where such documentation would be stored.

SENATOR CANNIZZARO:

The amendment you are referring to is the result of a request from the Nevada Resort Association and a couple of the State's Chambers of Commerce. They were concerned that if someone requested a certain type of accommodation, and the employer felt the accommodation was unreasonable, then documentation would be needed so that the employee could demonstrate what the issue was. I would be happy to ensure the amendment language requires employers to comply with HIPAA. I do not want employers to face any additional risk, and I do not want employees to worry about potentially sharing overly sensitive information.

SENATOR HARDY:

As a physician, I can write excuse notes, but giving details about a diagnosis is inappropriate. If the request could be for accommodation rather than medical documentation, that would be better and more compliant.

SENATOR CANNIZZARO:

That would be agreeable to me. The intent of this amendment was to demonstrate there was a reason for an accommodation. This amendment offers an additional safeguard to employers. I do not want employers to be overly burdened. I would be happy to work with the interested parties to ensure they are all right with the language Senator Hardy suggests.

CHAIR ATKINSON:

Are we changing language in the amendment?

SENATOR CANNIZZARO:

Yes. Instead of medical documentation, there would be documentation simply stating what the necessary accommodation was.

SENATOR HARDY:

I would agree to that language.

CHAIR ATKINSON:

Would this be an additional amendment, or would it change the existing one?

SENATOR CANNIZZARO:

The existing amendment would be changed.

How did we address rental car agencies?

JON SASSER (Legal Aid Center of Southern Nevada):

Rental car agencies are fine with the language in this bill.

Alfredo Alonso of the Alliance of Automobile Manufacturers brought up a concern with section 7 regarding whether this section might apply to communications between manufacturers and their captive finance companies. We tried to develop a conceptual amendment prior to this meeting, but this issue will require more discussion. I pledge to work with Mr. Alonso to figure this out before the House passage deadline on Tuesday, April 25.

CHAIR ATKINSON:

We can do a Floor amendment if necessary.

I am going to vote yes, but I reserve the right to change my vote on the Floor.

SENATOR SETTELMAYER:

There will most likely be continued work on this bill. I agree with the concept of developing a trained workforce; how we get there is going to be a part of this bill. Senate Bill 357 works hand in hand with the Governor's plans for workforce development, which are included in S.B. 516.

SENATE BILL 516: Revises provisions governing workforce innovation and apprenticeships. (BDR 53-913)

I am eager to see S.B. 357 continue to be refined. I support this bill.

CHAIR ATKINSON:

Not everybody is going to be happy with S.B. 357, but it is necessary. Like Senator Settelmeyer said, this bill will work hand in hand with the Governor's plans for workforce development.

SENATOR GANSERT:

I am going to vote yes, but I reserve the right to change my vote on the Floor.

SENATOR CANNIZZARO MOVED TO AMEND AND DO PASS AS AMENDED S.B. 357.

SENATOR SETTELMAYER SECONDED THE MOTION.

THE MOTION PASSED UNANIMOUSLY.

SENATOR GANSERT:

There is federal statute preempting how bookkeeping and records are addressed. I am not sure how we would be able to enforce this bill. Also, if someone called a place like the Charles Schwab Corporation and asked for advice, there is doubt as to whether these types of places would be covered. I am going to vote no because I am unsure if our State can pursue S.B. 383. There should be a responsibility to customers, but I am unsure how to reconcile the federal statute with S.B. 383 at the State level.

CHAIR ATKINSON:

Are you suggesting we wait for the federal government to act?

SENATOR GANSERT:

Because the regulation is at the federal level, we could be the only state that requires this. I am concerned that places like the Charles Schwab Corporation would no longer be able to do business in the State because of the requirements we place on them.

CHAIR ATKINSON:

I do not think that would be the case.

SENATOR HARDY:

This bill would affect upwards of 140,000 people who are defined as financial planners, but almost anyone who gives financial planning advice would be affected by this bill. The intent is good, and the concept is laudable, but S.B. 383 is not the best way to address the issue.

SENATOR SPEARMAN MOVED TO DO PASS S.B. 383.

SENATOR CANNIZZARO SECONDED THE MOTION.

SENATOR SPEARMAN:

Although I understand my colleagues' consternation with this bill, the protection for some of our most vulnerable citizens is important. We may never see a regulation at the federal level, but people continue to be swindled.

We had the opportunity to see a community solar garden in Minnesota sponsored by Xcel Energy. This bill is a comprehensive way to expand opportunities for renewable energy to seniors, low-income individuals and other groups.

SENATOR SETTELMAYER:

I am concerned about potentially raising rates to the extent that the benefits of renewable energy would disappear. I will not be supporting this bill, but I have supported many other renewable energy bills. I reserve the right to change my vote on the Floor.

There were some concerns from a urological standpoint. There is more to treating a child than the consideration of external genitalia. Other things are critical to the health of a child. These things should be in the physicians' hands.

SENATOR GANSERT:

Based on some of the testimony at this bill's hearing on Friday, April 7, I am going to vote no.

SENATOR SPEARMAN:

I respect the opinions of those who oppose this bill, but there is a difference between sex and gender. A lot of people do not see that.

CHAIR ATKINSON:

I have talked to a few people who have been adversely affected by a sex assignment at birth, and I am voting with them today.

SENATOR SETTELMAYER:

I wish we could find an amendment to address the urological side of this issue. I agree with the urological aspect of the opposition's testimony. I want to support this bill, but the urological aspect bothers me.

THE MOTION PASSED. (SENATORS GANSERT, HARDY AND SETTELMAYER VOTED NO.)

MS. PASLOV THOMAS:

I will read the summary of the bill and proposed amendments from the work session document ([Exhibit W](#)).

SENATOR HARDY:

With the amendments, I am going to vote yes. This bill is still a work in progress, so I reserve the right to change my vote on the Floor.

SENATOR CANCELA:

It is important for us and the proponents of this bill to make sure the right information is disseminated. Some chiropractors in my District strongly oppose this bill. I want to make sure they receive the correct information as to what the proposed amendments do and whether or not these amendments address their concerns.

SENATOR SETTELMAYER:

I appreciate the amendments, and I hope the interested parties were able to resolve their issues. Both physical therapists and chiropractors do fantastic things. I do not want the Legislature to be involved in a turf battle between the two groups.

CHAIR ATKINSON:

I believe the amendments address each group's issues.

SENATOR SPEARMAN:

I cannot see any reason to not support this bill. The distinction between physical therapists and chiropractors is clear in statute. If the distinction is not clear, we can always address that. I do not see anything in this bill that would cross the line into chiropractic practice. There was some discussion as to whether this bill would minimize the training chiropractors go through versus the training physical therapists go through. In every occupation, there are ancillary occupations, which does not mean one person's training is minimized if the training of another person is acknowledged. My yes vote does not mean I do

not appreciate the commitment of the chiropractors, nor does it minimize what the physical therapists have done.

SENATOR CANNIZZARO:

I echo the comments of my colleagues. Many individuals in my District are concerned about this bill. I understand this bill is a work in progress, so I hope the amendments address some of the issues I have heard about. I am going to vote yes, but I reserve the right to change my vote on the Floor. It is incumbent upon us to ensure everyone has the same information. We need to ensure we are making good decisions that are not going to put well-intentioned chiropractors or physical therapists out of business.

SENATOR CANCELA:

Until we see a final version of this bill, I am going to vote yes, but I reserve the right to change my vote on the Floor.

SENATOR GANSERT:

I am going to do the same as Senator Hardy, Senator Cannizzaro and Senator Cancela.
