- [A.B. 326](#) (R1)      Establishes a program to provide loans to certain operators of fresh food retailers located in underserved communities and similar areas. (BDR 18-318)
- [A.B. 533](#) (R1)      Revises provisions relating to cannabis. (BDR 60-1217)
- [S.B. 102](#)      Makes an appropriation for funding the participation of certain students who participate through the Western Regional Education Compact. (BDR S-98)
- [S.B. 166](#) (R2)      Revises provisions relating to employment. (BDR 18-5)
- [S.B. 193](#)      Makes an appropriation for educational programs relating to history, law and civics. (BDR S-368)
- [S.B. 402](#) (R1)      Makes various changes concerning educational programs relating to science, technology, engineering and mathematics and makes an appropriation. (BDR 43-887)
