- [S.B. 430](#) Expanding the definition of "chronic or debilitating medical condition" for certain purposes related to the medical use of marijuana. (BDR 40-1152)
- [S.B. 477](#) Prohibits the release of a child to a parent or guardian in certain circumstances. (BDR 38-1005)
