AN ACT making appropriations to the State Department of Agriculture for water conservation projects, the purchase of replacement vehicles and the purchase and replacement of laboratory equipment; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the State Department of Agriculture, Plant Health
3 and Quarantine Services, the sum of \$125,000 for water
4 conservation projects to facilitate the modernization of techniques
5 for irrigation and water storage for the agricultural and ranching
6 industries.
7 2. There is hereby appropriated from the State General Fund to
8 the State Department of Agriculture, Livestock Enforcement, the
9 sum of \$100,000 for the purchase of two replacement vehicles that
10 are equipped to carry out law enforcement functions.

1 3. There is hereby appropriated from the State General Fund to
2 the State Department of Agriculture, Veterinary Medical Services,
3 the sum of \$159,605 for new laboratory equipment.

4 4. There is hereby appropriated from the State General Fund to
5 the State Department of Agriculture, Veterinary Medical Services,
6 the sum of \$14,479 for the replacement of laboratory equipment.

7 **Sec. 2.** Any remaining balance of the appropriations made by
8 section 1 of this act must not be committed for expenditure after
9 June 30, 2021, by the entity to which the appropriation is made or
10 any entity to which money from the appropriation is granted or
11 otherwise transferred in any manner, and any portion of the
12 appropriated money remaining must not be spent for any purpose
13 after September 17, 2021, by either the entity to which the money
14 was appropriated or the entity to which the money was subsequently
15 granted or transferred, and must be reverted to the State General
16 Fund on or before September 17, 2021.

17 **Sec. 3.** This act becomes effective upon passage and approval.
