AN ACT making appropriations to the Department of Corrections for the Nevada Offender Tracking Information System, a key control system, replacement of power supply equipment, data racks, radios, scanners, computers and repeater upgrades; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund to the Department of Corrections the sum of \$420,000  
3 for the Nevada Offender Tracking Information System.  
4     2. There is hereby appropriated from the State General Fund to  
5 the Department of Corrections the sum of \$623,060 for the  
6 installation of a key control system for facilities.  
7     3. There is hereby appropriated from the State General Fund to  
8 the Department of Corrections the sum of \$96,100 for the  
9 replacement of uninterruptible power supply equipment.  
10    4. There is hereby appropriated from the State General Fund to  
11 the Department of Corrections the sum of \$3,390 for the purchase of  
12 data racks for the main data centers.



1        5. There is hereby appropriated from the State General Fund to  
2 the Department of Corrections the sum of \$152,371 for the  
3 replacement of handheld and vehicle radios and repeater upgrades.

4        6. There is hereby appropriated from the State General Fund to  
5 the Department of Corrections the sum of \$4,380 for the  
6 replacement of scanners.

7        7. There is hereby appropriated from the State General Fund to  
8 the Department of Corrections the sum of \$1,030,349 for the  
9 purchase of desktop and laptop computers.

10       **Sec. 2.** Any remaining balance of the appropriations made by  
11 section 1 of this act must not be committed for expenditure after  
12 June 30, 2021, by the entity to which the appropriation is made or  
13 any entity to which money from the appropriation is granted or  
14 otherwise transferred in any manner, and any portion of the  
15 appropriated money remaining must not be spent for any purpose  
16 after September 17, 2021, by either the entity to which the money  
17 was appropriated or the entity to which the money was subsequently  
18 granted or transferred, and must be reverted to the State General  
19 Fund on or before September 17, 2021.

20       **Sec. 3.** This act becomes effective upon passage and approval.
