AN ACT making appropriations to the Department of Public Safety for the replacement of computer hardware and software; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State General
2 Fund to the Training Division of the Department of Public Safety
3 the sum of \$27,387 for the replacement of computer hardware and
4 software.

5 **Sec. 2.** There is hereby appropriated from the State Highway
6 Fund to the Training Division of the Department of Public Safety
7 the sum of \$47,056 for the replacement of computer hardware and
8 software.

9 **Sec. 3.** (Deleted by amendment.)

10 **Sec. 4.** (Deleted by amendment.)

11 **Sec. 5.** 1. Any remaining balance of the appropriation made
12 by section 1 of this act must not be committed for expenditure after
13 June 30, 2021, by the entity to which the appropriation is made or
14 any entity to which money from the appropriation is granted or
15 otherwise transferred in any manner, and any portion of the

1 appropriated money remaining must not be spent for any purpose
2 after September 17, 2021, by either the entity to which the money
3 was appropriated or the entity to which the money was subsequently
4 granted or transferred, and must be reverted to the State General
5 Fund on or before September 17, 2021.

6 2. Any remaining balance of the appropriation made by section
7 2 of this act must not be committed for expenditure after June 30,
8 2021, by the entity to which the appropriation is made or any entity
9 to which money from the appropriation is granted or otherwise
10 transferred in any manner, and any portion of the appropriated
11 money remaining must not be spent for any purpose after
12 September 17, 2021, by either the entity to which the money was
13 appropriated or the entity to which the money was subsequently
14 granted or transferred, and must be reverted to the State Highway
15 Fund on or before September 17, 2021.

16 **Sec. 6.** This act becomes effective upon passage and approval.
