AN ACT making appropriations to the Department of Motor Vehicles for replacement of uninterruptible power supply equipment and Storage Area Network units, an upgrade to the Avaya telephone and PBX systems and CrowdStrike software; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 Highway Fund to the Division of Information Technology of the
- 3 Department of Motor Vehicles the sum of \$150,000 for the
- 4 replacement of uninterruptible power supply equipment.
- 5 2. There is hereby appropriated from the State Highway Fund
- 6 to the Division of Information Technology of the Department of
- 7 Motor Vehicles the sum of \$660,680 for the replacement of Storage
- 8 Area Network units.
- 9 3. There is hereby appropriated from the State Highway Fund
- 10 to the Division of Information Technology of the Department of

1 Motor Vehicles the sum of \$279,393 for an upgrade to the Avaya
2 telephone and PBX systems.

3 4. There is hereby appropriated from the State Highway Fund
4 to the Division of Information Technology of the Department of
5 Motor Vehicles the sum of \$93,500 for CrowdStrike software.

6 **Sec. 2.** Any remaining balance of the appropriations made by
7 section 1 of this act must not be committed for expenditure after
8 June 30, 2021, by the entity to which the appropriation is made or
9 any entity to which money from the appropriation is granted or
10 otherwise transferred in any manner, and any portion of the
11 appropriated money remaining must not be spent for any purpose
12 after September 17, 2021, by either the entity to which the money
13 was appropriated or the entity to which the money was subsequently
14 granted or transferred, and must be reverted to the State Highway
15 Fund on or before September 17, 2021.

16 **Sec. 3.** This act becomes effective upon passage and approval.
