ASSEMBLY CONCURRENT RESOLUTION—Directing the  
Legislative Commission to appoint a committee to  
conduct an interim study concerning wildfires.

1 WHEREAS, There is a growing threat of wildfires throughout the  
2 Western United States; and

3 WHEREAS, The State of Nevada has recently experienced  
4 several large and devastating wildfires; and

5 WHEREAS, A thorough legislative study of issues relating to  
6 wildfires is in the interest of the people of this State; now, therefore,  
7 be it

8 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE  
9 SENATE CONCURRING, That the Legislative Commission is hereby  
10 directed to appoint as soon as practicable a committee to conduct an  
11 interim study concerning wildfires, as described herein, which is  
12 composed of:

13 1. Three members of the Senate, two of whom are appointed  
14 by the Majority Leader of the Senate and one of whom is appointed  
15 by the Minority Leader of the Senate; and

16 2. Three members of the Assembly, two of whom are  
17 appointed by the Speaker of the Assembly and one of whom is  
18 appointed by the Minority Leader of the Assembly; and be it further

19 RESOLVED, That the Legislative Commission shall designate  
20 one of the members appointed to the committee to serve as the Chair  
21 of the committee; and be it further



1 RESOLVED, That in performing the study, the committee shall  
2 consider, without limitation:

3 1. Methods of reducing wildfire fuels;

4 2. Issues related to early responses to wildfires; and

5 3. The economic impact of wildfires on the State and local  
6 communities; and be it further

7 RESOLVED, That the committee should consult with and solicit  
8 input and recommendations from persons, entities and organizations  
9 with expertise in matters relevant to wildfires; and be it further

10 RESOLVED, That any recommended legislation proposed by the  
11 committee must be approved by a majority of the members of the  
12 Senate and a majority of the members of the Assembly appointed to  
13 the committee; and be it further

14 RESOLVED, That the Legislative Commission submit a report of  
15 the results of the study and any recommendations for legislation to  
16 the Director of the Legislative Counsel Bureau for transmittal to the  
17 81st Session of the Nevada Legislature; and be it further

18 RESOLVED, That this resolution becomes effective upon  
19 passage.
