AN ACT making supplemental appropriations to the Office of the Governor for an unanticipated shortfall in contract, utility and other operating costs; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State General Fund to the
2 Office of the Governor the sum of \$8,475 for a shortfall in the utility costs for the
3 Governor's Mansion. This appropriation is supplemental to that made by section 2
4 of chapter 396, Statutes of Nevada 2017, at page 2633.

5 **Sec. 2.** There is hereby appropriated from the State General Fund to the
6 Office of the Governor the sum of \$12,500 for a shortfall in operating costs. This
7 appropriation is supplemental to that made by section 2 of chapter 396, Statutes of
8 Nevada 2017, at page 2633.

9 **Sec. 3.** There is hereby appropriated from the State General Fund to the
10 Office of Finance in the Office of the Governor the sum of ~~[\$66,556]~~ **\$33,556** for a
11 shortfall for contract costs in the Budget Division of the Office of Finance. This
12 appropriation is supplemental to that made by section 2 of chapter 396, Statutes of
13 Nevada 2017, at page 2633.

14 **Sec. 4.** This act becomes effective upon passage and approval.
