AN ACT relating to disability services; ~~[requiring the Department of Health and Human Services to seek an increase in certain reimbursement rates under the Medicaid program and the Autism Treatment Assistance Program for a registered behavior technician];~~ requiring the Legislative Auditor to conduct an audit of the Medicaid program concerning the delivery of certain services; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law requires the Department of Health and Human Services to administer Medicaid. (NRS 422.270) ~~[Section 1 of this bill requires the Department to submit to the United States Secretary of Health and Human Services a request to amend the State Plan for Medicaid to increase the rate of reimbursement which is provided on a fee for service basis for services provided by a registered behavior technician to at least \$48 per hour. If that request is approved, section 1 requires the Autism Treatment Assistance Program, which is established within the Aging and Disability Services Division to serve as the primary autism program within the Department, to pay a rate of reimbursement for such services that is equal to or greater than the rate of reimbursement provided under Medicaid. (See NRS 427A.875).]~~ **Section 2** of this bill requires the Legislative Auditor to conduct an audit of the Department of Health and Human Services concerning the delivery of evidence-based services for persons with autism spectrum disorders during the 2019-2020 biennium.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. ~~[1. On or before October 1, 2019, the Department of Health and Human Services shall submit to the United States Secretary of Health and Human Services a request to amend the State Plan for Medicaid to increase the rate of reimbursement which is provided on a fee for service basis pursuant to the State Plan for services provided by a registered behavior technician to at least \$48 per~~

3 ~~2. If the amendment to the State Plan for Medicaid requested pursuant to~~

9 **Sec. 2.** 1. The Legislative Auditor shall conduct an audit during the 2019-
10 2021 biennium of the Medicaid program, including, without limitation, Medicaid
11 managed care programs, the Autism Treatment Assistance Program and any other
12 program or services provided through the Department of Health and Human
13 Services concerning the delivery of evidence-based services for children with
14 autism spectrum disorders. The audit must include, without limitation:

15 (a) An analysis of the capacity of persons who provide such services and the
16 wait times to receive such services;

17 (b) An identification and assessment of factors, including, without limitation,
18 rates of reimbursement, lack of providers of services, procedures for authorization
19 of services and delays in obtaining assessments and diagnoses, that inhibit access to
20 and delivery of such services; and

21 (c) An analysis of revenues and expenditures relating to such services and any
22 unspent money that has been appropriated for such services since July 1, 2015.

23 2. The Legislative Auditor shall present a final written report of the audit to
24 the Audit Subcommittee of the Legislative Commission by not later than January
25 31, 2021.

26 **Sec. 3.** This act becomes effective upon passage and approval.
