AN ACT relating to social workers; revising certain licensing fees; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Existing law establishes the maximum application and licensing fees the Board of Examiners for Social Workers may charge. (NRS 641B.300) This bill increases the maximum amounts that can be charged by the Board.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 641B.300 is hereby amended to read as follows:
641B.300 1. The Board shall charge and collect fees not to exceed the following amounts for:

Initial application	[\$40] \$200
Provisional license	[75] 150
Initial issuance of a license [, including a license by	
endorsement] as a social worker	[100] 250
<i>Initial issuance of a license as a clinical social worker</i>	
<i>or an independent social worker</i>	350
<i>Initial issuance of a license by endorsement</i>	200
<i>Annual renewal of a license as a social worker or an</i>	
<i>associate in social work</i>	[250] 175
Annual renewal of a license <i>as a clinical social worker</i>	
<i>or an independent social worker</i>	[\$150 \$350] 225
Restoration of a suspended license or reinstatement of a	
revoked license	150
Restoration of an expired license	200
Renewal of a delinquent license	100
[Reciprocal license without examination	100]
