**AN ACT** making appropriations to the Division of Child and Family Services for deferred maintenance projects and security camera system upgrades at various facilities; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** There is hereby appropriated from the State General Fund to the Division of Child and Family Services of the Department of Health and Human Services the sum of \$231,250 for deferred maintenance projects for the security and operation of the Caliente Youth Center.

**Sec. 2.** There is hereby appropriated from the State General Fund to the Division of Child and Family Services of the Department of Health and Human Services the sum of \$110,608 for the replacement of equipment of the Caliente Youth Center.

**Sec. 3.** There is hereby appropriated from the State General Fund to the Division of Child and Family Services of the Department of Health and Human Services the sum of \$780,206 for

1 deferred maintenance projects for the security and operation of the  
2 Nevada Youth Training Center.

3 **Sec. 4.** There is hereby appropriated from the State General  
4 Fund to the Division of Child and Family Services of the  
5 Department of Health and Human Services, Northern Nevada Child  
6 and Adolescent Services, the sum of \$113,396 for security camera  
7 system upgrades at the Adolescent Treatment Center, the Family  
8 Learning Homes and the agency administration building.

9 **Sec. 5.** There is hereby appropriated from the State General  
10 Fund to the Division of Child and Family Services of the  
11 Department of Health and Human Services, Southern Nevada Child  
12 and Adolescent Services, the sum of \$204,240 for the security and  
13 operation of the Children's Mental Health facilities.

14 **Sec. 6.** There is hereby appropriated from the State General  
15 Fund to the Division of Child and Family Services of the  
16 Department of Health and Human Services the sum of \$308,723 for  
17 deferred maintenance projects at the Summit View Youth Center.

18 **Sec. 7.** Any remaining balance of the appropriations made by  
19 sections 1 to 6, inclusive, of this act must not be committed for  
20 expenditure after June 30, 2021, by the entity to which the  
21 appropriation is made or any entity to which money from the  
22 appropriation is granted or otherwise transferred in any manner, and  
23 any portion of the appropriated money remaining must not be spent  
24 for any purpose after September 17, 2021, by either the entity to  
25 which the money was appropriated or the entity to which the money  
26 was subsequently granted or transferred, and must be reverted to the  
27 State General Fund on or before September 17, 2021.

28 **Sec. 8.** This act becomes effective upon passage and approval.
