Committee members should have before them the work session document that contains Senate Bill 94 (3rd Reprint) which was heard on May 20.

Senate Bill 94 (3rd Reprint): Revises provisions governing the Account for Family Planning. (BDR 40-446)

[Marsheilah Lyons read a description of the bill from the work session document (Exhibit C).] Senate Bill 94 (3rd Reprint) authorizes funds in the existing Account for Family Planning to also be used to pay for family planning services offered by providers of health care or for other services offered by a department or division of the Executive Department of state government through a contract with the recipient of the grant money. The bill revises the contraceptives and services for which money in the Account may be used to match similar lists in existing law. In addition, it requires family planning services paid for with money from the Account to be made available to all people who would otherwise have difficulty obtaining such services and appropriates \$6 million from the State General Fund to the Account for the 2019-2021 Biennium.
