Chair Carlton explained that the Committee had 26 Bill Draft Requests (BDRs) that needed approval for Committee introduction. Cindy Jones, Assembly Fiscal Analyst, Fiscal Analysis Division, Legislative Counsel Bureau, briefly explained the following BDRs to the members.

BDR S-1165 — Makes appropriations from the State General Fund to the Office of Finance in the Office of the Governor for an upgrade to the Nevada Executive Budget System and the replacement of office furniture. (Later introduced as <u>Assembly Bill 522</u>.)



- **BDR S-1166** Makes appropriations from the State General Fund and the State Highway Fund to the Office of Finance in the Office of the Governor for replacement of the Advantage Financial and Human Resources System with the Enterprise Resource Planning System. (Later introduced as <u>Assembly Bill 500</u>.)
- **BDR S-1171** Makes an appropriation from the State General Fund to the Office of Finance in the Office of the Governor to the Fleet Services Division of the Department of Administration as a loan for the replacement of vehicles. (Later introduced as Assembly Bill 501.)
- **BDR S-1172** Makes an appropriation from the State General Fund to the Office of Finance in the Office of the Governor for an electronic tracking system for Capital Improvement Projects. (Later introduced as <u>Assembly Bill 502</u>.)
- **BDR S-1174** Makes appropriations from the State General Fund and the State Highway Fund to the Fleet Services Division of the Department of Administration for the purchase of more vehicles. (Later introduced as <u>Assembly Bill 503</u>.)
- **BDR S-1177** Makes appropriations from the State General Fund to the Department of Agriculture for water conservation projects and the purchase and replacement of laboratory equipment. (Later introduced as <u>Assembly Bill 504</u>.)
- **BDR S-1180** Makes appropriations from the State General Fund to the Department of Conservation and Natural Resources for a paving project and maintenance at Ice Age Fossils State Park, self-pay kiosks, replacement of vehicles, and maintenance equipment for Sand Harbor at Lake Tahoe State Park. (Later introduced as <u>Assembly Bill 505</u>.)
- **BDR S-1182** Makes appropriations from the State General Fund to the Department of Corrections for the Offender Tracking Information System, a key control system, replacement of power supply equipment, data racks, radios, scanners and repeater upgrades. (Later introduced as <u>Assembly Bill 506</u>.)
- **BDR S-1183** Makes appropriations from the State General Fund to the Office of the Director of the Department of Corrections for the replacement of buses and other vehicles. (Later introduced as <u>Assembly Bill 507</u>.)
- **BDR S-1185** Makes an appropriation from the State General Fund to the Department of Corrections for the replacement of medical equipment. (Later introduced as <u>Assembly Bill 508</u>.)
- **BDR S-1187** Makes an appropriation from the State General Fund to the Equal Rights Commission for the new automation solution to streamline the intake process. (Later introduced as Assembly Bill 509.)

- **BDR S-1190** Makes an appropriation from the State General Fund to the Department of Motor Vehicles for the Automatic Voter Registration Initiative. (Later introduced as <u>Assembly Bill 510</u>.)
- **BDR S-1191** Makes appropriations from the State Highway Fund to the Department of Motor Vehicles for replacement of uninterruptible power supply equipment and Storage Area Network units, an upgrade to the Avaya phone and PBX systems and CrowdStrike software. (Later introduced as Assembly Bill 523.)
- **BDR S-1194** Makes appropriations from the State General Fund and the State Highway Fund to the Investigations Division of the Department of Public Safety for the replacement of computer software and hardware equipment and vehicles. (Later introduced as <u>Assembly Bill 511</u>.)
- **BDR S-1216** Makes appropriations from the State General Fund to the Division of Enterprise Information Technology Services of the Department of Administration as a loan for implementation and replacement of computer applications. (Later introduced as Assembly Bill 512.)
- **BDR S-1219** Makes appropriations from the State General Fund and the State Highway Fund to the Training Division of the Department of Public Safety for the replacement of computer software and hardware equipment and building maintenance. (Later introduced as <u>Assembly Bill 513.</u>)
- **BDR S-1225** Makes an appropriation from the State General Fund to the Secretary of State for implementation of the Automatic Voter Registration Initiative. (Later introduced as Assembly Bill 514.)
- **BDR S-1227** Makes appropriations from the State General Fund to the Legislative Fund for dues to national organizations, computer hardware replacements, building maintenance projects, and reimbursement of the costs for the consultant retained by the Nevada Right to Counsel Commission and travel expenses of members. (Later introduced as <u>Assembly Bill 515</u>.)
- **BDR S-1229** Makes appropriations from the State General Fund for both years of the biennium to the Interim Finance Committee for the unanticipated costs related to Marsy's Law. (Later introduced as <u>Assembly Bill 516.</u>)
- **BDR S-1230** Makes supplemental appropriations from the State General Fund to the Office of the Governor for an unanticipated shortfall in contracts, utilities and other operating costs. (Later introduced as <u>Assembly Bill 517</u>.)

- **BDR S-1233** Makes a supplemental appropriation from the State Highway Fund to the Division of Public and Behavioral Health of the Department of Health and Human Services for an unanticipated shortfall in indirect cost rate revenue. (Later introduced as <u>Assembly Bill 518</u>.)
- **BDR S-1234** Makes a supplemental appropriation from the State General Fund to the Office of the Director of the Department of Corrections for an unanticipated shortfall in utilities, inmate driven and food costs. (Later introduced as <u>Assembly Bill 524</u>.)
- **BDR S-1237** Makes a supplemental appropriation from the State General Fund to Division of State Parks of the Department of Conservation and Natural Resources for terminal leave payout costs. (Later introduced as <u>Assembly Bill 525</u>.)
- **BDR S-1240** Makes appropriations from the State General Fund to the Stale Claims Account and the Interim Finance Contingency Account to restore the fund balances. (Later introduced as <u>Assembly Bill 519</u>.)
- **BDR S-1244** Makes appropriations from the State General Fund to the Division of Public and Behavioral Health of the Department of Health and Human Services for a web-based Community Health Services system and the replacement of computer software and hardware equipment at various facilities and a skid-steer. (Later introduced as Assembly Bill 520.)
- **BDR S-1258** Makes a supplemental appropriation from the State General Fund to the State Controller for a projected shortfall related to payroll. (Later introduced as <u>Assembly Bill 521.</u>)
