Cindy Jones, Assembly Fiscal Analyst, Fiscal Analysis Division, Legislative Counsel Bureau, briefly explained the four BDRs to the members and said BDR 32-1197, BDR 41-1207, and BDR 43-1209 were budget implementation bills.

BDR 32-1197 – Revises provisions governing periodic background investigations of state employees who have access to confidential information. (Later introduced as Assembly Bill 530.)

- **BDR 41-1207** Revises provisions governing the Nevada Athletic Commission. (Later introduced as <u>Assembly Bill 529</u>.)
- BDR 43-1209 Revises provisions governing the penalty for a lapse of motor vehicle insurance. (Later introduced as <u>Assembly Bill 531.</u>)
- **BDR 43-1211** Revises provisions governing sales of motor vehicles. (Later introduced as Assembly Bill 532.)
