**SENATE BILL 391**: Revises provisions relating to deputy marshals in certain courts. (BDR 1-69)

SENATE BILL 173: Revises provisions relating to criminal convictions of victims of sex trafficking and involuntary servitude. (BDR 14-595)

**SENATE BILL 252**: Authorizes the residential confinement or other appropriate supervision of certain older offenders. (BDR 16-1050)

Mr. Guinan:

<u>Senate Bill 252</u> is described in work session document (<u>Exhibit E</u>). Senator Cannizzaro proposes to amend the bill by raising the ages of offenders to whom these provisions apply.

SENATOR HANSEN MOVED TO PASS AND DO PASS AS AMENDED S.B. 252.

<u>SENATE BILL 265</u>: Revises provisions relating to certain records of mental health. (BDR 14-1042)

**SENATE BILL 342**: Revises provisions relating to animals. (BDR 14-748)

Mr. Guinan:

Work session document (Exhibit G) summarizes S.B. 342 and the amendment.

#### SENATOR SCHEIBLE:

The amendments do not alter the spirit of the bill.

SENATOR HAMMOND MOVED TO AMEND AND DO PASS AS AMENDED S.B. 342.

SENATOR OHRENSCHALL SECONDED THE MOTION.

#### SENATOR PICKARD:

I have not had time to look at the amendment, but there seems to be substantive changes. Section 8 adds a fitness test, but there is no guidance given for the test.

## SENATOR SCHEIBLE:

The bill addresses two situations. One instance is when an animal is impounded when the owner is detained for any reason, and "able and fit" applies to owners who have had pets seized pursuant to a cruelty investigation.

## **SENATOR PICKARD:**

Is the fitness test in another section of law?

#### SENATOR SCHEIBLE:

It is caselaw.

THE MOTION CARRIED. (SENATOR PICKARD VOTED NO.)

#### CHAIR CANNIZZARO:

I will close the work session on  $\underline{S.B.\ 342}$  and open the work session on  $S.B.\ 438$ .

**SENATE BILL 438**: Establishes the circumstances in which a confession by itself is sufficient to warrant the conviction of a defendant. (BDR 14-927)

Mr. Guinan:

Senate Bill 438 is summarized in work session document (Exhibit H).

SENATOR HANSEN MOVED TO AMEND AND DO PASS AS AMENDED S.B. 438.

SENATOR PICKARD SECONDED THE MOTION.

THE MOTION CARRIED. (SENATOR OHRENSCHALL VOTED NO.)

**SENATE BILL 480**: Revises provisions relating to the number of justices of the peace in each township. (BDR 1-978)

SENATOR PICKARD MOVED TO AMEND AND DO PASS AS AMENDED S.B. 480.

SENATOR HANSEN SECONDED THE MOTION.

SENATE BILL 325: Establishes the Nevada Child Adoption Grant Program to provide grants to assist certain prospective adoptive parents with certain costs of adoption. (BDR 11-163)

SENATOR OHRENSCHALL MOVED TO REREFER <u>S.B. 325</u> TO THE SENATE COMMITTEE ON FINANCE.

SENATOR DONDERO LOOP SECONDED THE MOTION.

THE MOTION PASSED UNANIMOUSLY.

## CHAIR CANNIZZARO:

I will close the work session on  $\underline{S.B.\ 325}$  and open the work session on  $S.B.\ 368$ .

**SENATE BILL 368**: Revises provisions relating to protections for victims of crime. (BDR 2-166)

#### Mr. Guinan:

The work session document ( $\underline{\text{Exhibit J}}$ ) summarizes  $\underline{\text{S.B. 368}}$ . The most recent amendment ( $\underline{\text{Exhibit K}}$ ) and supporting documentation ( $\underline{\text{Exhibit L}}$ ) are in your packets.

## CHAIR CANNIZZARO:

The language in the amendment is not seeking to institute a new pre-prosecution diversion program, it would apply to existing programs. Victims of sex trafficking have access to pre-prosecution diversion programs when they are arrested for charges of prostitution.

Section 21 will be deleted.

SENATOR PAT SPEARMAN (Senatorial District No. 1):

We are willing to compromise on the statute of limitations in order to pass the bill.

SENATOR SCHEIBLE MOVED TO AMEND AND DO PASS AS AMENDED S.B. 368.

SENATOR HARRIS SECONDED THE MOTION.

THE MOTION CARRIED. (SENATORS HAMMOND AND HANSEN VOTED NO.)
