**SENATE BILL 263**: Revises provisions relating to the regulation and taxation of certain vapor products and tobacco products. (BDR 32-700)

Joe Reel (Deputy Fiscal Analyst):

<u>Senate Bill 263</u> is sponsored by Senator Julia Ratti and was heard in this Committee on March 28 and May 27. This bill establishes provisions to require certain vapor products and tobacco products, including electronic cigarettes, cigars, cigarillos, pipes and similar products or devices and their components, to be regulated and taxed in the same manner as other tobacco products. The work session document is submitted (Exhibit C).

Subsequent to yesterday's hearing, Senator Ratti proposed an additional amendment (<u>Exhibit D</u>). This amendment clarifies the exclusion for marijuana products.
