<u>S.B. 166 (R1)</u>	Revises provisions relating to crimes motivated by certain characteristics of the victim. (BDR 15-246)
<u>S.B. 203</u> (R1)	Revises provisions relating to civil actions involving certain sexual offenses. (BDR 2-577)
