<u>S.B. 7</u> (R1)	Makes various changes to the jurisdiction of certain courts relating to certain orders for protection where the adverse party is a child under 18 years of age. (BDR 1-391)
<u>S.B. 19</u> (R1)	Establishes provisions authorizing certain entities to obtain information relating to the records of criminal history of certain persons responsible for the safety and well-being of children, elderly persons or persons with disabilities. (BDR 14-336)
S.B. 359 (R1)	Provides additional penalties if a fire or explosion results from the commission

of certain prohibited acts. (BDR 40-1006)
