<u>S.B. 434</u>	Makes an appropriation to the Office of Finance in the Office of the Governor for the construction of a medical school at the University of Nevada, Las Vegas. (BDR S-1064)
<u>S.B. 435</u>	Makes appropriations to the Office of Finance in the Office of the Governor for the costs associated with the replacement of the Advantage Financial and Human Resources System with the Enterprise Resource Planning System and furnishings for the operations center for the System. (BDR S-1052)
<u>S.B. 436</u>	Repeals the prospective expiration of a provision revising the distribution of certain money collected from certain administrative assessments. (BDR S-1138)
<u>S.B. 444</u>	Makes a supplemental appropriation to the State Distributive School Account for an unanticipated decrease in revenues for the 2019-2020 and 2020-2021 school years. (BDR S-1054)
