

ASSEMBLY BILL NO. 102—ASSEMBLYMEN KRASNER, FLORES;
MCARTHUR, O'NEILL AND ROBERTS

SUMMARY—Revises requirements for the issuance of certain annual permits for entering, camping and boating in state parks and recreational areas. (BDR 35-877)

AN ACT relating to state lands; revising certain requirements relating to the issuance to certain veterans of an annual permit for entering, camping and boating in state parks and recreational areas; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Under existing law, the Division of State Parks of the State Department of
2 Conservation and Natural Resources is required to issue an annual permit for
3 entering, camping and boating in all state parks and recreational areas in this State
4 to certain persons including a bona fide resident of this State who has incurred a
5 permanent service-connected disability of 10 percent or more and has been
6 honorably discharged from the Armed Forces of the United States. The permit must
7 be issued without charge, but the Division is required to impose an administrative
8 fee to cover the costs of issuing the permit. (NRS 407.065) This bill eliminates the
9 requirement that the permanent service-connected disability rating be of 10 percent
10 or more.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 407.065 is hereby amended to read as follows:
2 407.065 1. The Administrator, subject to the approval of the
3 Director:
4 (a) Except as otherwise provided in this paragraph and NRS
5 407.066, may establish, name, plan, operate, control, protect,

1 develop and maintain state parks, monuments and recreational areas
2 for the use of the general public. The name of an existing state park,
3 monument or recreational area may not be changed unless the
4 Legislature approves the change by statute.

5 (b) Shall protect state parks and property controlled or
6 administered by the Division from misuse or damage and preserve
7 the peace within those areas. The Administrator may appoint or
8 designate certain employees of the Division to have the general
9 authority of peace officers.

10 (c) May allow multiple use of state parks and real property
11 controlled or administered by the Division for any lawful purpose,
12 including, but not limited to, grazing, mining, development of
13 natural resources, hunting and fishing, in accordance with such
14 regulations as may be adopted in furtherance of the purposes of the
15 Division.

16 (d) Except as otherwise provided in this section, shall impose
17 and collect reasonable fees for entering, camping and boating in
18 state parks and recreational areas. The Division shall issue an annual
19 permit for entering, camping and boating in all state parks and
20 recreational areas in this State:

21 (1) Upon application therefor and proof of residency and age,
22 to any bona fide resident of the State of Nevada who is 65 years of
23 age or older.

24 (2) Upon application therefor and proof of residency and
25 proof of status as described in subsection 5 of NRS 361.091, to a
26 bona fide resident of the State of Nevada who has incurred a
27 permanent service-connected disability ~~{of 10 percent or more}~~ and
28 has been honorably discharged from the Armed Forces of the United
29 States.

30 ➡ The permit must be issued without charge, except that the
31 Division shall charge and collect an administrative fee for the
32 issuance of the permit in an amount sufficient to cover the costs of
33 issuing the permit.

34 (e) May conduct and operate such special services as may be
35 necessary for the comfort and convenience of the general public,
36 and impose and collect reasonable fees for such special services.

37 (f) May rent or lease concessions located within the boundaries
38 of state parks or of real property controlled or administered by the
39 Division to public or private corporations, to groups of natural
40 persons, or to natural persons for a valuable consideration upon such
41 terms and conditions as the Division deems fit and proper, but no
42 concessionaire may dominate any state park operation.

43 (g) May establish such capital projects construction funds as are
44 necessary to account for the parks improvements program approved
45 by the Legislature. The money in these funds must be used for the



1 construction and improvement of those parks which are under the
2 supervision of the Administrator.

3 (h) In addition to any concession specified in paragraph (f), may
4 establish concessions within the boundaries of any state park to
5 provide for the sale of food, drinks, ice, publications, sundries, gifts
6 and souvenirs, and other such related items as the Administrator
7 determines are appropriately made available to visitors. Any money
8 received by the Administrator for a concession established pursuant
9 to this paragraph must be deposited in the Account for State Park
10 Interpretative and Educational Programs and Operation of
11 Concessions created by NRS 407.0755.

12 2. The Administrator:

13 (a) Shall issue an annual permit to a person who pays a
14 reasonable fee as prescribed by regulation which authorizes the
15 holder of the permit to enter each state park and each recreational
16 area in this State and, except as otherwise provided in subsection 4,
17 use the facilities of the state park or recreational area without paying
18 the entrance fee; and

19 (b) May issue an annual permit to a person who pays a
20 reasonable fee as prescribed by regulation which authorizes the
21 holder of the permit to enter a specific state park or specific
22 recreational area in this State and, except as otherwise provided in
23 subsection 4, use the facilities of the state park or recreational area
24 without paying the entrance fee.

25 3. The Administrator shall establish a program for the issuance
26 of an annual permit, free of charge, to enter each state park and
27 recreational area in this State to any pupil who is enrolled in the fifth
28 grade at a school in this State. The program must:

29 (a) Specify the period for which the Administrator may issue an
30 annual permit to a pupil pursuant to this subsection, including,
31 without limitation, the date upon which the Administrator may issue
32 an annual permit to a pupil who has completed fourth grade and
33 who intends to enter the fifth grade after completing the fourth
34 grade;

35 (b) Specify the circumstances under which a pupil and any
36 person accompanying a pupil may use the annual permit to enter a
37 state park or recreational area; and

38 (c) Include any other requirement which the Administrator
39 determines is necessary to establish and carry out the program
40 pursuant to this subsection.

41 4. An annual permit issued pursuant to subsection 2 or 3 does
42 not authorize the holder of the permit to engage in camping or
43 boating, or to attend special events. The holder of such a permit who
44 wishes to engage in camping or boating, or to attend special events,
45 must pay any fee established for the respective activity.



5. During each Public Lands Day observed pursuant to NRS 236.053, and upon proof of residency in this State, the Division shall allow a resident of this State to enter, camp and boat in any state park or recreational area without the payment of any fees for those activities. The free day of camping authorized pursuant to this subsection must include either the Friday night before Public Lands Day or overnight on the night of Public Lands Day, as determined by the Administrator for each state park and recreational area. A person is not entitled to receive more than one free night of camping during each Public Lands Day pursuant to this subsection.

6. Except as otherwise provided in subsection 1 of NRS 407.0762 and subsection 1 of NRS 407.0765, the fees collected pursuant to paragraphs (d), (e) and (f) of subsection 1 or subsection 2 must be deposited in the State General Fund.

Sec. 2. 1. This section becomes effective upon passage and approval.

2. Section 1 of this act becomes effective:

(a) Upon passage and approval for the purpose of adopting any regulations and performing any other preparatory administrative tasks that are necessary to carry out the provisions of this act; and

(b) On July 1, 2021, for all other purposes.
