AN ACT making appropriations to the Department of Corrections for an upgrade to and reintegration of certain management systems and for replacement cameras, storage area networks and ovens; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. 1. There is hereby appropriated from the State General Fund to the Department of Corrections the sum of \$2,189,808 for an upgrade to the Offender Management System.

2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently

1 granted or transferred, and must be reverted to the State General
2 Fund on or before September 15, 2023.

3 **Sec. 2.** 1. There is hereby appropriated from the State
4 General Fund to the Department of Corrections the sum of
5 \$1,436,720 for the reintegration of the Offender Sentence
6 Management System into the Nevada Offender Tracking
7 Information System.

8 2. Any remaining balance of the appropriation made by
9 subsection 1 must not be committed for expenditure after June 30,
10 2023, by the entity to which the appropriation is made or any
11 entity to which money from the appropriation is granted or
12 otherwise transferred in any manner, and any portion of the
13 appropriated money remaining must not be spent for any purpose
14 after September 15, 2023, by either the entity to which the money
15 was appropriated or the entity to which the money was subsequently
16 granted or transferred, and must be reverted to the State General
17 Fund on or before September 15, 2023.

18 **Sec. 3.** 1. There is hereby appropriated from the State
19 General Fund to the Department of Corrections the sum of \$247,012
20 for replacement cameras and storage area networks.

21 2. Any remaining balance of the appropriation made by
22 subsection 1 must not be committed for expenditure after June 30,
23 2023, by the entity to which the appropriation is made or any
24 entity to which money from the appropriation is granted or
25 otherwise transferred in any manner, and any portion of the
26 appropriated money remaining must not be spent for any purpose
27 after September 15, 2023, by either the entity to which the money
28 was appropriated or the entity to which the money was subsequently
29 granted or transferred, and must be reverted to the State General
30 Fund on or before September 15, 2023.

31 **Sec. 4.** 1. There is hereby appropriated from the State
32 General Fund to the Department of Corrections the sum of \$102,747
33 for replacement ovens at the High Desert State Prison.

34 2. Any remaining balance of the appropriation made by
35 subsection 1 must not be committed for expenditure after June 30,
36 2023, by the entity to which the appropriation is made or any
37 entity to which money from the appropriation is granted or
38 otherwise transferred in any manner, and any portion of the
39 appropriated money remaining must not be spent for any purpose
40 after September 15, 2023, by either the entity to which the money
41 was appropriated or the entity to which the money was subsequently
42 granted or transferred, and must be reverted to the State General
43 Fund on or before September 15, 2023.
