SUMMARY—Revises provisions governing an application for a temporary change relating to appropriated water. (BDR 48-309)

AN ACT relating to water; revising provisions governing an application for a temporary change relating to water already appropriated; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

With certain exceptions, existing law requires a person who wishes to change the place of diversion, manner of use or place of use of water already appropriated to apply to the State Engineer for a permit to do so. (NRS 533.325) Existing law requires the State Engineer to hold a hearing on an application for a temporary change to the place of diversion, manner of use or place of use of water already appropriated if the State Engineer determines that such a change may not be in the public interest or may impair the water rights of others. (NRS 533.345) This bill ~~makes the holding of a hearing on such an application discretionary.~~ clarifies that a person may file a written protest against the granting of an application for a temporary change and provides that the State Engineer may hold a hearing in accordance with the procedures set forth in existing law.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** NRS 533.345 is hereby amended to read as follows:

533.345 1. Every application for a permit to change the place of diversion, manner of use or place of use of water already appropriated must contain such information as may be necessary to a full understanding of the proposed change, as may be required by the State Engineer.

2. If an applicant is seeking a temporary change of place of diversion, manner of use or place of use of water already appropriated, the State Engineer shall approve the application if:

(a) The application is accompanied by the prescribed fees;

1 (b) The temporary change is in the public interest; and

2 (c) The temporary change does not impair the water rights held by other  
3 persons.

4 3. If the State Engineer determines that the temporary change may not be in  
5 the public interest, or may impair the water rights held by other persons, the State  
6 Engineer shall give notice of the application as provided in NRS 533.360. ~~and~~  
7 ~~hold a hearing and render a decision as provided in this chapter. The~~ Any person  
8 interested may file a written protest to the application and the State Engineer may  
9 hold a hearing ~~on the application~~ before rendering a decision ~~in~~ in accordance  
10 with the provisions of NRS 533.365.

11 4. A temporary change may be granted for any period not to exceed 1 year.

12 **Sec. 2.** This act becomes effective on July 1, 2021.
