AN ACT making appropriations to the Department of Taxation for the replacement of ~~computer~~ **information technology** hardware and software and printers; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State General Fund to
2 the Department of Taxation the sum of \$146,822 for the replacement of computer
3 hardware and software.

4 2. Any remaining balance of the appropriation made by subsection 1 must not
5 be committed for expenditure after June 30, 2023, by the entity to which the
6 appropriation is made or any entity to which money from the appropriation is
7 granted or otherwise transferred in any manner, and any portion of the appropriated
8 money remaining must not be spent for any purpose after September 15, 2023, by
9 either the entity to which the money was appropriated or the entity to which the
10 money was subsequently granted or transferred, and must be reverted to the State
11 General Fund on or before September 15, 2023.

12 **Sec. 2.** 1. There is hereby appropriated from the State General Fund to the
13 Department of Taxation the sum of \$68,912 for the replacement of printers.

14 2. Any remaining balance of the appropriation made by subsection 1 must not
15 be committed for expenditure after June 30, 2023, by the entity to which the
16 appropriation is made or any entity to which money from the appropriation is
17 granted or otherwise transferred in any manner, and any portion of the appropriated
18 money remaining must not be spent for any purpose after September 15, 2023, by
19 either the entity to which the money was appropriated or the entity to which the

1 money was subsequently granted or transferred, and must be reverted to the State
2 General Fund on or before September 15, 2023.

3 *Sec. 3. 1. There is hereby appropriated from the State General Fund to*
4 *the Department of Taxation the sum of \$259,743 for the replacement of*
5 *information technology hardware.*

6 *2. Any remaining balance of the appropriation made by subsection 1*
7 *must not be committed for expenditure after June 30, 2023, by the entity to*
8 *which the appropriation is made or any entity to which money from the*
9 *appropriation is granted or otherwise transferred in any manner, and any*
10 *portion of the appropriated money remaining must not be spent for any*
11 *purpose after September 15, 2023, by either the entity to which the money was*
12 *appropriated or the entity to which the money was subsequently granted or*
13 *transferred, and must be reverted to the State General Fund on or before*
14 *September 15, 2023.*

15 *Sec. 4. 1. There is hereby appropriated from the State General Fund to*
16 *the Department of Taxation the sum of \$40,032 for the replacement of*
17 *printers.*

18 *2. Any remaining balance of the appropriation made by subsection 1*
19 *must not be committed for expenditure after June 30, 2023, by the entity to*
20 *which the appropriation is made or any entity to which money from the*
21 *appropriation is granted or otherwise transferred in any manner, and any*
22 *portion of the appropriated money remaining must not be spent for any*
23 *purpose after September 15, 2023, by either the entity to which the money was*
24 *appropriated or the entity to which the money was subsequently granted or*
25 *transferred, and must be reverted to the State General Fund on or before*
26 *September 15, 2023.*
