AN ACT making appropriations to the Division of Child and Family Services of the Department of Health and Human Services for deferred maintenance projects at certain facilities; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. 1. There is hereby appropriated from the State General Fund to the Division of Child and Family Services of the Department of Health and Human Services the sum of \$145,790 for deferred maintenance projects at Summit View Youth Center.

2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently



1 granted or transferred, and must be reverted to the State General
2 Fund on or before September 15, 2023.

3 **Sec. 2.** 1. There is hereby appropriated from the State
4 General Fund to the Division of Child and Family Services of the
5 Department of Health and Human Services the sum of \$56,969 for
6 deferred maintenance projects at the Caliente Youth Center.

7 2. Any remaining balance of the appropriation made by
8 subsection 1 must not be committed for expenditure after June 30,
9 2023, by the entity to which the appropriation is made or any entity
10 to which money from the appropriation is granted or otherwise
11 transferred in any manner, and any portion of the appropriated
12 money remaining must not be spent for any purpose after
13 September 15, 2023, by either the entity to which the money was
14 appropriated or the entity to which the money was subsequently
15 granted or transferred, and must be reverted to the State General
16 Fund on or before September 15, 2023.

17 **Sec. 3.** 1. There is hereby appropriated from the State
18 General Fund to the Division of Child and Family Services of the
19 Department of Health and Human Services the sum of \$129,908
20 for deferred maintenance projects at the Nevada Youth Training
21 Center.

22 2. Any remaining balance of the appropriation made by
23 subsection 1 must not be committed for expenditure after June 30,
24 2023, by the entity to which the appropriation is made or any entity
25 to which money from the appropriation is granted or otherwise
26 transferred in any manner, and any portion of the appropriated
27 money remaining must not be spent for any purpose after
28 September 15, 2023, by either the entity to which the money was
29 appropriated or the entity to which the money was subsequently
30 granted or transferred, and must be reverted to the State General
31 Fund on or before September 15, 2023.

32 **Sec. 4.** 1. There is hereby appropriated from the State
33 General Fund to the Division of Child and Family Services of the
34 Department of Health and Human Services the sum of \$433,894 for
35 deferred maintenance projects at the Southern Nevada Child and
36 Adolescent Services Campus.

37 2. Any remaining balance of the appropriation made by
38 subsection 1 must not be committed for expenditure after June 30,
39 2023, by the entity to which the appropriation is made or any entity
40 to which money from the appropriation is granted or otherwise
41 transferred in any manner, and any portion of the appropriated
42 money remaining must not be spent for any purpose after
43 September 15, 2023, by either the entity to which the money was
44 appropriated or the entity to which the money was subsequently



1 granted or transferred, and must be reverted to the State General
2 Fund on or before September 15, 2023.

3 **Sec. 5.** This act becomes effective upon passage and approval.
