SUMMARY—Makes appropriations to the Nevada Highway Patrol Division of the Department of Public Safety for the replacement of vehicles and motorcycles and certain equipment. (BDR S-1129)

AN ACT making appropriations to the Nevada Highway Patrol Division of the Department of Public Safety for the replacement of vehicles and motorcycles and certain equipment; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. 1. There is hereby appropriated from the State Highway Fund to the Nevada Highway Patrol Division of the Department of Public Safety the sum of \$10,433,390 for the replacement of fleet vehicles and associated special equipment.

2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently



1 granted or transferred, and must be reverted to the State Highway
2 Fund on or before September 15, 2023.

3 **Sec. 2.** 1. There is hereby appropriated from the State
4 Highway Fund to the Nevada Highway Patrol Division of the
5 Department of Public Safety the sum of \$278,772 for the
6 replacement of fleet motorcycles and associated special equipment.

7 2. Any remaining balance of the appropriation made by
8 subsection 1 must not be committed for expenditure after June 30,
9 2023, by the entity to which the appropriation is made or any entity
10 to which money from the appropriation is granted or otherwise
11 transferred in any manner, and any portion of the appropriated
12 money remaining must not be spent for any purpose after
13 September 15, 2023, by either the entity to which the money was
14 appropriated or the entity to which the money was subsequently
15 granted or transferred, and must be reverted to the State Highway
16 Fund on or before September 15, 2023.

17 **Sec. 3.** 1. There is hereby appropriated from the State
18 Highway Fund to the Nevada Highway Patrol Division of the
19 Department of Public Safety the sum of \$400,750 for oral fluid
20 mobile analyzers and cartridges to be used for alcohol-related
21 offenses.

22 2. Any remaining balance of the appropriation made by
23 subsection 1 must not be committed for expenditure after June 30,
24 2023, by the entity to which the appropriation is made or any entity
25 to which money from the appropriation is granted or otherwise
26 transferred in any manner, and any portion of the appropriated
27 money remaining must not be spent for any purpose after
28 September 15, 2023, by either the entity to which the money was
29 appropriated or the entity to which the money was subsequently
30 granted or transferred, and must be reverted to the State Highway
31 Fund on or before September 15, 2023.

32 **Sec. 4.** 1. There is hereby appropriated from the State
33 Highway Fund to the Nevada Highway Patrol Division of the
34 Department of Public Safety the sum of \$1,211,984 for the
35 replacement of mobile data computer tablets.

36 2. Any remaining balance of the appropriation made by
37 subsection 1 must not be committed for expenditure after June 30,
38 2023, by the entity to which the appropriation is made or any entity
39 to which money from the appropriation is granted or otherwise
40 transferred in any manner, and any portion of the appropriated
41 money remaining must not be spent for any purpose after
42 September 15, 2023, by either the entity to which the money was
43 appropriated or the entity to which the money was subsequently
44 granted or transferred, and must be reverted to the State Highway
45 Fund on or before September 15, 2023.



Sec. 5. 1. There is hereby appropriated from the State Highway Fund to the Nevada Highway Patrol Division of the Department of Public Safety the sum of \$238,989 for equipment items for the Division's multidisciplinary investigation and reconstruction teams.

2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State Highway Fund on or before September 15, 2023.

Sec. 6. 1. There is hereby appropriated from the State Highway Fund to the Nevada Highway Patrol Division of the Department of Public Safety the sum of \$143,043 for the replacement of printers and associated mobile adapters.

2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State Highway Fund on or before September 15, 2023.

Sec. 7. 1. There is hereby appropriated from the State Highway Fund to the Nevada Highway Patrol Division of the Department of Public Safety the sum of \$198,050 for the replacement of computer hardware and software.

2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State Highway Fund on or before September 15, 2023.



1 **Sec. 8.** This act becomes effective upon passage and approval.
