SUMMARY—Makes appropriations to the Division of Public and Behavioral Health of the Department of Health and Human Services for maintenance and repairs and the replacement of certain equipment at certain facilities operated by the Division that provide mental health services. (BDR S-1121)

AN ACT making appropriations to the Division of Public and Behavioral Health of the Department of Health and Human Services for maintenance and repairs and the replacement of certain equipment at certain facilities operated by the Division that provide mental health services; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Division of Public and Behavioral Health of the
3 Department of Health and Human Services the sum of \$1,457,870
4 for the maintenance and repair of Building Nos. 1, 2, 3, 3A, 6 and
5 6A on the Southern Nevada Adult Mental Health Services Campus.
6 2. Any remaining balance of the appropriation made by
7 subsection 1 must not be committed for expenditure after June 30,
8 2023, by the entity to which the appropriation is made or any entity

1 to which money from the appropriation is granted or otherwise
2 transferred in any manner, and any portion of the appropriated
3 money remaining must not be spent for any purpose after
4 September 15, 2023, by either the entity to which the money was

11 the maintenance and repair of Building No. 3 and Building No. 1 of
12 the Rawson Neal Psychiatric Hospital on the Southern Nevada
13 Adult Mental Health Services Campus.

14 2. Any remaining balance of the appropriation made by
15 subsection 1 must not be committed for expenditure after June 30,
16 2023, by the entity to which the appropriation is made or any entity
17 to which money from the appropriation is granted or otherwise
18 transferred in any manner, and any portion of the appropriated
19 money remaining must not be spent for any purpose after
20 September 15, 2023, by either the entity to which the money was
21 appropriated or the entity to which the money was subsequently
22 granted or transferred, and must be reverted to the State General
23 Fund on or before September 15, 2023.

24 **Sec. 3.** 1. There is hereby appropriated from the State
25 General Fund to the Division of Public and Behavioral Health of the
26 Department of Health and Human Services the sum of \$565,500 for
27 the maintenance and repair of Building Nos. 1 and 2 of the Rawson
28 Neal Psychiatric Hospital on the Southern Nevada Adult Mental
29 Health Services Campus.

30 2. Any remaining balance of the appropriation made by
31 subsection 1 must not be committed for expenditure after June 30,
32 2023, by the entity to which the appropriation is made or any entity
33 to which money from the appropriation is granted or otherwise
34 transferred in any manner, and any portion of the appropriated
35 money remaining must not be spent for any purpose after
36 September 15, 2023, by either the entity to which the money was
37 appropriated or the entity to which the money was subsequently
38 granted or transferred, and must be reverted to the State General
39 Fund on or before September 15, 2023.

40 **Sec. 4.** 1. There is hereby appropriated from the State
41 General Fund to the Division of Public and Behavioral Health of the
42 Department of Health and Human Services the sum of \$111,860 for
43 deferred maintenance projects at Building No. 25 of the Dini-
44 Townsend Hospital and the Central Kitchen in Building No. 26 on
45 the Northern Nevada Adult Mental Health Services Campus.



2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State General Fund on or before September 15, 2023.

Sec. 5. 1. There is hereby appropriated from the State General Fund to the Division of Public and Behavioral Health of the Department of Health and Human Services the sum of \$51,534 for deferred maintenance projects at Building Nos. 8 and 8A on the Northern Nevada Adult Mental Health Services Campus.

2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State General Fund on or before September 15, 2023.

Sec. 6. 1. There is hereby appropriated from the State General Fund to the Division of Public and Behavioral Health of the Department of Health and Human Services the sum of \$261,362 for deferred maintenance projects at Building No. 13 on the Northern Nevada Adult Mental Health Services Campus.

2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State General Fund on or before September 15, 2023.

Sec. 7. 1. There is hereby appropriated from the State General Fund to the Division of Public and Behavioral Health of the Department of Health and Human Services the sum of \$27,285 for the replacement of kitchen equipment in Building No. 13 on the Northern Nevada Adult Mental Health Services Campus.



2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money was appropriated or the entity to which the money was subsequently granted or transferred, and must be reverted to the State General Fund on or before September 15, 2023.

Sec. 8. This act becomes effective upon passage and approval.
