INTRODUCTION, FIRST READING AND REFERENCE

Assembly Bill No. 140—AN ACT relating to civil actions; requiring certain lessors of vehicles to accept service of process under certain circumstances;

requiring such lessors to transmit a copy of the service of process to certain lessees; and providing other matters properly relating thereto.
