INTRODUCTION, FIRST READING AND REFERENCE

By Assemblywoman Cohen and Senator Ohrenschall:

Assembly Bill No. 145—AN ACT relating to judgments; adopting the Uniform Registration of Canadian Money Judgments Act; and providing other matters properly relating thereto.

Assemblyman Yeager moved that the bill be referred to the Committee on Judiciary.

By Assemblywoman Peters:

Assembly Bill No. 146—AN ACT relating to water; requiring the State Department of Conservation and Natural Resources to establish a program regulating water pollution resulting from diffuse sources; establishing requirements for applicants for certain permits relating to water pollution to post a bond or other surety; revising requirements for regulations adopted by the State Environmental Commission relating to water pollution; revising notice requirements relating to regulations adopted by the Commission; revising various provisions relating to the control of water pollution by the Director of the Department; revising requirements relating to the control of diffuse sources of water pollution; revising various requirements for permits to discharge a pollutant or inject fluids through a well; requiring the Director to consult or notify Indian tribes of certain actions relating to water pollution; and providing other matters properly relating thereto.

Assemblyman Watts moved that the bill be referred to the Committee on Natural Resources.

By Assemblywoman Nguyen:

Assembly Bill No. 147—AN ACT relating to counties; authorizing a board of county commissioners to create by ordinance the office of county counsel; providing for the appointment of a county counsel; establishing the qualifications of a county counsel; authorizing a county counsel to appoint deputies and certain other staff; setting forth the powers and duties of a county counsel; revising the responsibilities of the district attorney when the office of county counsel is created; and providing other matters properly relating thereto.

Assemblyman Flores moved that the bill be referred to the Committee on Government Affairs.

Assembly Bill No. 148—AN ACT relating to mining; prohibiting certain persons from obtaining a permit to engage in an exploration project or mining operation; and providing other matters properly relating thereto.

Assemblyman Watts moved that the bill be referred to the Committee on Natural Resources.

By Assemblymen Peters, Yeager and Torres:

Assembly Bill No. 149—AN ACT relating to cannabis; authorizing a cannabis independent testing laboratory to submit a complaint to the Cannabis Compliance Board concerning certain debts owed to the laboratory; requiring the Board to take certain actions regarding such complaints; requiring the Board to impose a civil penalty upon a cannabis cultivation facility or cannabis production facility that fails to pay certain debts owed to a cannabis independent testing laboratory within a certain period of time; requiring the Board to create an electronic database containing certain information relating to the testing of cannabis and cannabis products by a cannabis independent testing laboratory; and providing other matters properly relating thereto.

Assemblyman Yeager moved that the bill be referred to the Committee on Judiciary.

By the Committee on Growth and Infrastructure:

Assembly Bill No. 150—AN ACT relating to special license plates; revising provisions governing certain terminations and suspensions of certain special license plates; revising provisions governing certain fees collected by the Department of Motor Vehicles on behalf of certain charitable organizations; and providing other matters properly relating thereto.

Assemblywoman Monroe-Moreno moved that the bill be referred to the Committee on Growth and Infrastructure.

Motion carried.

By Assemblymen González, Torres, Anderson, Flores, Nguyen, Watts and Yeager; Senators Donate and Hammond:

Assembly Bill No. 151—AN ACT relating to offenses; revising provisions relating to the collection of delinquent fines, administrative assessments, fees and restitution; revising provisions relating to the suspension of the driver's license of a person under certain circumstances; and providing other matters properly relating thereto.

Assemblyman Yeager moved that the bill be referred to the Committee on Judiciary.

By Assemblymen Krasner, Yeager and Marzola:

Assembly Bill No. 152—AN ACT relating to debt collection; imposing certain requirements and restrictions relating to the collection of a debt by the person to whom the debt is owed; and providing other matters properly relating thereto.

By Assemblywoman Bilbray-Axelrod and Senator Brooks:

Assembly Bill No. 153—AN ACT relating to public financial administration; clarifying that a local government may use any savings realized under a performance contract to make payments required under the performance contract; making a legislative declaration to encourage using agencies to utilize performance contracts to implement operating cost-savings measures; and providing other matters properly relating thereto.

Assemblyman Flores moved that the bill be referred to the Committee on Government Affairs.

Assembly Bill No. 154—AN ACT relating to public utilities; authorizing public utilities to provide certain notice to customers electronically; and providing other matters properly relating thereto.

waivers granted, assigned or reassigned to members and eligible persons; and providing other matters properly relating thereto.
