INTRODUCTION, FIRST READING AND REFERENCE

Assembly Bill No. 181—AN ACT relating to mental health; providing for the reporting of certain information by certain health-related facilities relating to suicide; requiring certain insurers and other organizations providing health coverage to adhere to certain provisions of federal law; requiring certain insurers and other organizations providing health coverage to submit a report demonstrating mental health parity and addiction equity compliance; and providing other matters properly relating thereto.

Assembly Bill No. 183—AN ACT relating to collective bargaining; removing the exemption from compliance with certain provisions requiring a meeting to be open or public for meetings between a local government or Executive Department employer and an employee organization or employees as individuals; and providing other matters properly relating thereto.

GENERAL FILE AND THIRD READING

Assembly Bill No. 110.

Bill read third time.

Remarks by Assemblywoman Brittney Miller.

ASSEMBLYWOMAN BRITTNEY MILLER:

Assembly Bill 110 revises the Nevada Lobbying Disclosure and Regulation Act by removing the requirement that to be designated as a lobbyist, a person must appear in person in the Legislative Building or other building where the Legislature or its committees hold meetings. This bill clarifies that a person is not considered to be a lobbyist if he or she communicates with members of the Legislative Branch on an infrequent or irregular basis and does not otherwise engage in lobbying activities. Finally, the measure specifies the registration requirements that are applicable during the 81st Legislative Session to a person who, on or after the effective date of this bill, qualifies as a lobbyist.
