Remarks by Assemblyman O'Neill.

ASSEMBLYMAN O'NEILL:

Senate Bill 25 repeals provisions in NRS Chapters 372 and 374 to maintain the state's compliance with the Streamlined Sales and Use Tax Agreement, of which Nevada is a full member state. The bill eliminates a requirement of existing law which predates Nevada's adoption of the Streamlined Sales and Use Tax Agreement and which requires the Department of Taxation, in determining whether food intended for human consumption is subject to the sales and use tax, to base its determination on whether the food is intended for immediate consumption and not on the type of establishment where the food is sold.

Senate Bill No. 35.

Bill read third time.

Remarks by Assemblywoman Marzola.

ASSEMBLYWOMAN MARZOLA:

Senate Bill 35 abolishes the fund for the Private Investigator's Licensing Board from the State General Fund and requires the Board to establish an account in a financial institution in the state of Nevada. The bill requires that any money collected, except fines in certain circumstances, must be deposited in the new account and such money must be used for expenses incurred in carrying out the Board's powers and duties.

Senate Bill No. 74.

Bill read third time.

Remarks by Assemblywoman Kasama.

ASSEMBLYWOMAN KASAMA:

Senate Bill 74 eliminates the requirement for the Department of Taxation to use the population totals issued by the Bureau of the Census of the United States Department of Commerce [Census Bureau] for the purposes of distributing certain taxes and making certain determinations based on population in the case of a conflict between the population totals certified by the Governor and the population totals issued by the Census Bureau. The bill also eliminates obsolete references to the terms "enterprise district," "local government," and "special district" as they are not referenced or used for the administration of the provisions of NRS Chapter 377.
