Assembly Resolution No. 7—Adding former Deputy Research Director of the Research Division of the Legislative Counsel Bureau Marsheilah D. Lyons to the Assembly Wall of Distinction.

WHEREAS, The Assembly of the Legislature of the State of Nevada has established an Assembly Wall of Distinction for those past members and staff selected by leadership who served with great distinction and who made exemplary contributions to the State of Nevada; and

WHEREAS, Marsheilah D. Lyons was born in 1971 in Fort Bragg, North Carolina, to a military family that traveled the world before eventually settling in Algiers, Louisiana; and

WHEREAS, Marsheilah always possessed a love of learning and excelled academically, graduating at the top of her class from O. Perry Walker High School in New Orleans at the age of 16, and subsequently earning a Bachelor of Science in Occupational Education and Human Services from Wayland Baptist University and a Master of Arts in Christian Education with an emphasis in Social Work from the New Orleans Baptist Theological Seminary; and

WHEREAS, Her family and career paths eventually led Marsheilah to northern Nevada where she pursued her calling to public service, working in various community relations and educational settings before accepting a position as Senior Research Analyst with the Research Division of the Nevada Legislative Counsel Bureau in August 2000; and

WHEREAS, While she served as the lead Committee Policy Analyst for many legislative committees, it was Marsheilah's long-standing contributions to health and human services-related

committees where she had the most profound impact, specifically the Assembly and Senate Committees on Health and Human Services, and numerous interim committees, including the Legislative Committee on Health Care; the Legislative Committee on Senior Citizens, Veterans and Adults With Special Needs; and the Subcommittee to Conduct a Study of Postacute Care; and

WHEREAS, She was well-known for her expertise in health care matters, capably advising legislators and colleagues in her thoughtful, impartial, yet convincing way and becoming a prominent state and national expert in the field through her involvement with the National Conference of State Legislatures and the Council of State Governments; and

WHEREAS, Marsheilah was noted for her outstanding management skills, emotional intelligence, political savvy, quick wit and, perhaps most importantly, her compassion for others, kindness and keen sense of justice, which contributed to her quick ascension through the ranks of the Research Division and her appointment as Deputy Research Director in 2019; and

WHEREAS, Despite her unmatched professional accomplishments, Marsheilah's most important role was that of wife to William, mother to daughter Marshay and son William III, mother-in-law to Quentin, grandmother to Zara, as a loving daughter, sister, aunt and friend, and dedicated servant to God and her church, the Greater New Hope Baptist Church in Reno, Nevada; now, therefore, be it

RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, That for her dedicated service and unparalleled contributions to the Nevada Legislature and the State of Nevada as a whole, for the joy she brought to those around her, and for her endearing friendship to us all, former Deputy Research Director, Marsheilah D. Lyons, is hereby added to the Assembly Wall of Distinction; and be it further

RESOLVED, That the Chief Clerk of the Assembly prepare and transmit a copy of this resolution to the family of former Deputy Research Director Marsheilah Lyons; and be it further

RESOLVED, That this resolution becomes effective upon adoption.

ASSEMBLYWOMAN MONROE-MORENO:

My freshman year—we all get assigned a policy analyst—I got Marsheilah as my assignment. She had a presence that was just overwhelming. When I got to know her better she said, "Oftentimes I am assigned legislators who go on to become leaders. Sometimes they are leaders here in the legislative body, but sometimes they are leaders in other aspects of their lives. I see you being a leader," she said. "So for that, I want you to know I will be praying for you. Even when you do not know I am, I will always be praying for you."

She was a leader in this building, but as I got involved in national organizations, with CSG [Council of State Governments] and NCSL [National Conference of State Legislatures], I got to see Marsheilah being a leader on a national level, moving policy not just in this state, but nationwide.

I want you all to know that she cared about us. She was family. For her family, I want you to know that we love Marsheilah. You are our family. We will be here for you no matter what you need at any time of day or night because that is what Marsheilah was for us; she was always there for us.

This building is a lonelier place without having her in it. I will miss calling on her for legislative advice and personal life advice. She became my legislative mama. We love you; we will miss her, but we are here for you always.

ASSEMBLYWOMAN TITUS:

I rise in passionate support of Assembly Resolution 7. Anybody who knew Marsheilah knew that she was dedicated, not only to this institution, but dedicated to her family, and most of all dedicated to her faith. She touched all of us who knew her even in a casual way. Just last week I was giving testimony on one of my bills that had sat in Ways and Means for awhile; the original hearing was several months ago. I opened up my folder on that bill and the opening remarks had been written by Marsheilah.

She will be with us forever. I still have a picture of the day your little baby was born, her little granddaughter. She sent me that picture and I sent her pictures of my grandchildren. I will keep it forever. She is in my heart. She is in the heart of everyone she touched.

She has changed a lot of this building, and we should all aspire to be even a fraction as good a Marsheilah.

MR. SPEAKER:

I will take a point of personal privilege. I really appreciated the family allowing us to be a part of her celebration of life. That is what this is. I was not joking when I mentioned at her celebration of life that for me and for many of us, Marsheilah was the meeting after the meeting. Marsheilah was the one that gave me a look that something was not happening right. I knew I had to meet with Marsheilah. As I stated earlier, Assemblywoman Carlton's life passion had been making sure we took care of health care and in particular surprise billing. That was Assemblywoman Carlton's life long passion, but that was what Marsheilah got done for us. She gave me that look and I knew I had to get this right.

We certainly appreciate your lending her to us for a little while. I was looking at my phone and I turned 40-11—I am going to stay in my forties as long as I can—I turned 40-11 on March 19. Marsheilah was going through her own things on March 19, and she found room to pray for me. That is who she was. She is the first of many African Americans in the things she has done and the leadership that she has shown nationally. To have her on that wall says such a big thing about what she meant to this institution.
