Chair Miller:

Senate Bill 268: Revises provisions relating to state financial administration.
(BDR 17-545)

Pepper Sturm, Committee Policy Analyst:

I cannot advocate for or against any legislation. I am just here to walk you through the work session document [[Exhibit C](#)]. Senate Bill 268 requires, to the extent of available resources, the Fiscal Analysis Division of the Legislative Counsel Bureau to perform a budget stress test in each even-numbered year. The stress test must compare the estimated future revenue to, and the estimated future expenditure from, the major funds in the State Treasury under various potential economic conditions. A report regarding the results of the test must be posted on the Legislature's website and submitted to the Governor and the Legislature. The bill was heard on May 11, 2021, and sponsored by Senator Harris. There were no amendments to this bill.
